(d) remove meter parking places and replace them with single yellow line 'controlled hours' waiting restrictions in the following locations (approximate number of vehicle spaces shown in brackets):

(i) Anglesea Road, the south-west side, between Anglesea Avenue and Masons Hill (5 spaces);

(ii) Bardsley Lane, the south side, outside Lamb House and Bardsley (iii) John Wilson Street, the access road leading to Jim Bradley Close,

the south-west side (8 spaces);

(iv) **Maidenstone Hill**, the south-west side, opposite undercliff (2 spaces);

(v) Parry Place, the east side, outside the Ashley Centre (3 spaces); (vi) Spray Street, both sides between Parry Place and Burrage Road

(4 spaces); (vii) Vincent Road, the south side, between Helen Street and Burrage Road (13 spaces);

(e) remove shared-use (permits and pay and display) parking places and replace them with resident and business parking space in the following locations (approximate number of vehicle spaces shown in brackets)

(i) Old Woolwich Road, the south side, outside Nos. 62 to 80 Old Woolwich Road (9 spaces);

(ii) Trafalgar Grove, the south-west side, outside Travers House (6 spaces) and outside Nos. 26 and 27 Trafalgar Grove (2 spaces);

(f) on the north-east side of Polytechnic Street, between Calderwood Street and Bathway, remove a solo motorcycle parking place and replace it with pay and display parking space for two vehicles;

(g) in King William Walk, on the west side between Nos. 15 and 16 King William Walk and on the east side opposite Nos. 1 and 2 King William Walk to remove 2-hour maximum stay meter parking space for 3 vehicles and replace it with 30 minute maximum stay pay and display parking space;

(h) in Prior Street, on the east side, adjacent to No. 11 Circus Street, to remove 2-hour maximum stay meter parking space for two vehicles and replace it with 4-hour maximum stay pay and display parking space; and

(i) with the exception of the changes referred to in paragraphs (b) to (h) inclusive above, convert the meter parking places in Anglesea Road, Ashburnham Place, Bathway, Brookhill Road, Burney Street, Calderwood Street, Catherine Grove, College Approach, Greenwich Church Street, Greenwich South Street, Horseferry Place, Hyde Vale, King George Street, Lindsell Street, Market Street, Peyton Place, Plumbridge Street, Polytechnic Street, Roan Street, Royal Place, Spray Street and Straightsmouth (within the Greenwich Town Centre CPZ, Woolwich Arsenal CPZ and Market Street CPZ) to pay and display parking places. The types of vehicle that may be left in those parking places, the hours during which vehicles may be left in those parking places and the charges for leaving vehicles in those parking places would remain unchanged.
