PROPOSED WAITING RESTRICTIONS IN WOODFIELD ROAD AT THE ENTRANCE TO ST GREGORY'S PRIMARY SCHOOL

THE EALING (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (AMENDMENT NO. *) ORDER 201*

1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing ("the Council") proposes, in connection with preventing parking across the emergency access to St Gregory's Primary School, to make the above mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Order would be to implement waiting restrictions which would apply "at any time" in Woodfield Road on the east side, between a point 4.1 metres south of the common boundary of Nos. 41 and 43 Woodfield Road and a point 19.2 metres south of that common boundary;
3. The Order, other documents giving more detailed particulars of the Order, are available for inspection at Customer Services Reception, Perceval House, 14-16 Uxbridge Road W5 2HL between 9:00am and 4:45pm on Monday to Friday, until 6 weeks have elapsed from the date on which either the Order is made or the Council decides not to make the Order.

PROVISION OF WAITING RESTRICTIONS IN THE LANCASTER ROAD AND LOWDEN ROAD AND 20 MPH SPEED LIMIT ZONE EXTENSION

THE EALING (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (AMENDMENT NO. 573) ORDER 2013

THE EALING (20 MPH SPEED LIMIT) (NO. 3, 2005) (AMENDMENT NO.1) TRAFFIC ORDER 2013

1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing ("the Council") on the 8th August 2013 made the above mentioned Orders under sections 6, 84 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Speed Limit Order will be to extend the 20mph zone to include Lancaster Road (north of Lowden Road to the end of public highway), Lowden Road, Honeysuckle Close, Jasmine Close, Foxglove Close, Marigold Close and Orchid Close.
3. The general effect of the Waiting Restriction Order will be to impose double yellow line waiting restrictions applying "at any time" in the lengths of streets specified in the Schedule to this Notice.
4. The Orders, which will come into operation on 12th August 2013, other documents giving more detailed particulars of the Orders, are available for inspection at Customer Services Reception, Perceval House, 14-16 Uxbridge Road W5 2HL between 9:00am and 4:45pm on Monday to Friday, until the 20th September 2013.
5. If any person wishes to question the validity of either of the Orders or of any of their provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within six weeks from the date on which the Order is made, apply for the purpose to the High Court.

Foxglove Close
All of the road except on the north side, outside Nos. 11 to 14 and on the south side, between a point 10 metres east of Lancaster Road and the northern boundary of No.3 Foxglove Close

Honeysuckle Close

(a) The north side

(i) Between Lancaster Road and the western boundary of Nos. 35/37Honeysuckle Close;

(ii) Between a point 11.8 metres west the western boundary of Nos. 35/37Honeysuckle Close and the eastern wall of Nos. 32/34 Honeysuckle Close;

(iii) Between a point 1 metre east of the western wall of No. 30 Honeysuckle Close and its western extremity;

(b) The south side

(i) Between Lancaster Road and the western boundary of Nos. 35/37 Honeysuckle Close;

(ii) Between a point 3 metres west of the western wall of No. 16 Honeysuckle Close and its western extremity;

(c) The west side, between a point 5 metres south of the north side and a point 5 metres north of the south side

Jasmine Close

All of the road except on the west side between a point 10 metres north of Lancaster Road and a point 30 metres north of Lancaster Road

Lancaster Road

(a) The east side

(i) Between a point 3.2 metres west of the western wall of No. 70 and a point 11.9 metres west of that wall;

(ii) Between a point 5 metres west of Jasmine Close and a point 5 metres east of Jasmine Close;

(iii) Between a point 3 metres east of No. 96 Lancaster road and a point opposite the western wall of No. 112 Lancaster Road;

(iv) Between a point 5 metres east of Marigold Close and a point 10 metres west of Marigold Close;

(b) The west side

(i) Between the common boundary of Nos. 57 and 59 Lancaster Road and a point 5.1 metres west of the western wall of No. 81 Lancaster Road;

(ii) Between a point 5 metres east of Honeysuckle Close and a point 10 metres west of Honeysuckle Close;

(iii) Between the eastern wall of Nos. 1/3 Orchid Close and a point 7 metres west of Orchid Close.

Lowden Road

(a) the north side

(i) between its junction with Lancaster Road and a point opposite the south-eastern wall of No. 61 Lancaster Road;

(ii) between the common boundary of Nos. 10 and 11 Honeysuckle Close and the eastern boundary of Nos. 15 to 25 Lowden Road;

(iii) between a point opposite the north-western wall of Nos. 27 to 37 Lowden Road and its western extremity;

(b) the south side

(i) between its junction with Lancaster Road and a point opposite the western wall of No. 48 Lowden Road;

(ii) between a point 10 metres west of a point opposite the western wall of No. 48 Lowden Road and its western extremity;

(iii) the west side, between a point 5 metres south of the north side and a point 5 metres north of the south side.

Marigold Close

All of the road except in the layby outside No. 12 Marigold Close on the north side.

Orchid Close

All of the road except on (a) the north side, between a point 10 metres west of Lancaster Road and a point 35 metres west of Lancaster Road and (b) the west side, between a point 5 metres south of the north side and a point 5 metres north of the south side. (1881276)
