Paris, May 30, N. S. The following Extract of the Advices received by the Court relating to the Plague, has been communicated to the foreign Minifters.

The Duke de Roquelaure in his Letters of the 13th and 14th of May writes, that fince the 21ft of April none had died or fallen fick at Mende. M. Blanquet M. Blanquer a Phylician was ordered to go to la Canourgue, and give Direction for difinitecting (or perfuming and airing) it a fecond Time, as foon as there flould be Advice of its being in a fettled State of Health. The Block de of St. Gaussi and all the Course included Blockade of its being in a lettled state of Health. The Blockade of St. Genaix and all the Country inclofed within the two Lines, continued in perfect Health. The Accident of fome Perfons dying lately of the Plague (as was believed) at Marfeilles, had induced the Duke do R complexes and M de Bernare to direct the Duke de Roquelaure and M.de Bernage to direct the Offices of Health at Cette and at Agde, not to adthe Offices of Health at Cette and at Ague, not to su-mit any thing which fhould come from that City, but fuchGoods only as fhould come from the other Places of Provence, unlefs with Certificates figned by the Marquefs de Brancas, to whom this Order had been fignified. M. de Bernage writes the 15th of May, that three Perfons had died fuddenly in one Night and in one Mayfe at Cornillon near Bagnols; but that and in oue Houfe at Cornillon near Bagnols ; but that they had poifoned themfelves with bad Mufhrooms; no Mark of Contagion was found on their Bodies. The Chevalier Damas writes the 15th of May, that except at Alais, where the Sickness has not quite ceafed, and where 12 Perfons have died fince its Relapfe, the Gevaudan, the Vivaretz, and the reft of the Country are perfectly recovered. M. de Rothe writes the 13th of May, that all the late Accidents had not had any bad Confequences, and he was of O-pinion none were to be feared; however Cornillon had been put under Quarantain, becaufe of the Accident happening by the bad Mushrooms. A Man fuspected of the Contagion in the Parish of St. George de l'Euejac, was grown well again, having had only an ordinary Diftemper

Provence. M. de Pilles Governour of Marfeilles, in his Letter of the 10th of May writes, that on the 9th a Servant Maid had died of a doubtful Diffemper; fhe had kept her Bed four Days, and during three ot them had no Marks of Infection on her. All Preparations were made tor an Holpital in Cale of Need, but he was in hopes those Precautions would be ulelefs. M de Graud Maison the Commanding Officer in Fort St. John at Marseilles, writes the 11th of May, that by the Death of feveral Perfons fince the 8th the breaking out of the Plague anew at Marfeilles was confirmed. Should the Diftemper increase a lit-

tle more, the Gallies would remove to the Arfenal, tle more, the Gallies would remove to the Arfenal, and the Troops would keep by themfelves. The Marquefs de Brancas writes the 13th of May, that finte the 11th at Night four had died or fallen lick in the fame Street where the firft were taken ill, and that Street was barricaded the 13th. A Surgeon was fallen fick. All proper Difpofitions were made, in Cafe of a further Relapfe, for Holpitals, Places for Quarantain, Infirmaries, Buriers of the Dead, Phy-ficians, and Surgeons: Barriers were fettled, and ge-nerally whatever is neceffary for preventing the be-ing furbrized. ing furprized. The Marquess de Nogaret writes the 4th of May, that he had fpoke that Day to the Marquess de Galean at the Barrier of Avignon, who told him that during the four preceed-ing Days the Diffemper had much decreated there, who told him that during the four preceeding Days the Diffemper had much decreated there, and that but iew died or fell fick. Two Per-fons out of feveral who had concealed infected Goods had been feverely whipped. A Quaran-tain was beginning there. Those who fhall come out of their Houles are to pay a large Fine, and if they are not able to pay it, the Men are to be made Buriers of the dead, and the Women to be mide Nurfes to infected Perfons. It was feared this would not be regularly observed, because the People flill continue incover able. continue ungovernable.
