St. James's, the 31st Day of May, 1722. .

IS Majesty in Council was this Day pleased to order, that the Parliament, which flands prorogued to Tuesday the 5th of June next, should be further prorogued to Tuesday the 3d of July following.

St. James's, June 1. This Day the following humble Address of the President, Vice-President, Treasurer, Court of Assistants, and Body of the Artillery. Most Gracious Sovereinn,

Turin, May 30, N.S. Yesterday the Court set out from hence for the Veneria, there to pass all the next Month, and then to remove as usually to Rivoli when the Hears grow excessive in the Plains. The Abbot d'Augrogue is to be recalled from Genoa, and M. Gross to be fent thither in his Room. We have Advice from thence, that two Spanish Vessels were driven in there last Week by contrary Winds, one of which had Stores and 150 Soldiers on board for Porto-Longone. They write from Venice, that the Procurators Sig. Tiepolo and Foscarini were preparing

to fet out on their Embassy to the Court of France.

Hamboure, June 3. The last Letters from Moscow tell us the Czar was preparing for his Journey to Altracan, in order to his intended Enterprize on certain Provinces near the Caspian Sea. In the mean time his Czari h Majesty had received Advice, that the two Circassian Princes, who by the Disorders they committed last Year about Schamachia gave him a Pretence for this Ui dertaking, have put themselves under the Protection of the Turks on the News of his Preparations. This has had such an Influence on his Resolutions, that the Instructions for the Minister he is sending to the Persian Court are changed, and instead of a sort of Declaration of War which he was to carry, he has now Orders to represent to the Sophy, that since the Persians are not in a Condition to chastise those Rebels (for one of the Circassian Princes was tributary to them, and the other to the Czar) he is resolved to do it himself, but that as soon as he has reduced them to their Duty, and secured those Parts and the Trade of his Subjects there for the future, he will reflore to the Persians whatever belongs to them, and maintain a constant Friendship with that Crown.

St. James's, June 1. This Evening His Majesty went from hence to His Palace at Kenfington.

Whitehall, April 16, 1722. This is to fignify in His Majesty's Name, that if any Person or Persons shall hereafter apprehend any one or more Highwaymen, who from and after the Date hereof shall have robbed any of the Mails, or shall have been concerned as Accomplices in the robbing of any of them, such Person or Persons shall have a Reward of Two Hundred Pounds for each Offender, who shall be convicted thereof, to be paid by the Receiver General of the Post-Office, over and above the Reward directed by Att of Parliament for apprehending of Highwaymen; or if any Person hereaster concerned in robbing any of the Mails shall make a Discovery of the same, so that his Accom-plies or Accomplices shall be convicted thereof, such Perfon shall have His Majesty's most gracious Pardon, and also receive the Reward of Two Hundred Pounds for each Offender fo convicted, to be paid as aforesaid.
