PROVISION OF DISABLED PERSONS PARKING PLACES

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Merton under the powers conferred by sections 6 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers propose to make the above mentioned Order.

2. The general effects of the Order will be to:—

- (a) designate parking places in the roads listed on the Schedule to this Notice in which vehicles authorised by the Order may be left for any period during the permitted hours without charge;
- (b) provide that the parking place will operate at all times, unless otherwise stated;
- (c) specify, in respect of the parking place, that disabled persons' vehicles displaying, in the relevant position, a disabled persons badge (commonly referred to as "the Blue Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 2000 may be left therein; and
- (d) provide that certain vehicles may wait in the parking places in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), etc.
