AN humble Address from the Lieutenant, High Sheriff, Deputy Lieutenants, and Justices of the Peace of the North Riding of the County of York, has been presented to His Majesty by the Honourable Conyers Darcy, Esq; Lieutenant and Custos Rotulorum of the said Riding, accompanied by several Gentlemen of that County, who had all the Honour to kiss His Majesty's Hand.

Which Address His Majesty was pleased to receive very graciously.

Dresden, May 30. On the 25th Instant Mr. Scot the British Minister had Audience of Leave of the King of Poland. To-morrow he sets out from hence for Pretsch, to take like Audience of the Queen of Poland; and will then proceed to the Court of Berlin.

Berlin, June 5. James Scot, Esq; His Britannick Majesty's Minister, is arrived here. The Lord Whitworth His Britannick Majesty's Ambassadour Plenipotentiary, set out from hence this Morning for Holland, there to embark for England.

Cambray, June 8, N. S. This being His Britannick Majesty's Birth Day, his Excellency the Lord Polwarth gave a very splendid Entertainment to all the Ambassadours and Ministers and other Persons of Distinction of both Sexes at this Place. There were four Tables with twenty four Covers each; and after Dinner and Supper there was a Ball: The Court and the Gardens of his Excellency's Hôtel were illuminated.

Hague, June 12, N. S. Yesterday arrived at Rotterdam the Catherine Yacht, which is to carry over the Lord Whitworth to England.

HIS Swedish Majesty having always at Heart to promote and advance Commerce in a free and unlimited Course, as far as may be consistent with the Security of his Dominions, has therefore out of such tender Regards been pleased to make in the several Regulations already published the following Alterations and Modifications.

1. Since the Place hitherto ordered for the performing of Quarantain, viz. Karingöen, is somewhat out of the Road for Shipping, his Majesty has therefore, for their greater Conveniency, ordered and pitch'd in Lieu thereof, on a Place called Kohlsund, situated within Winga, by the Road of Elsborg near Gottenborough.

2. To this Place are only required to go those Ships, that either come from infected Places in France, the Levant, or are laden with any Goods from thence: All other Ships coming from the West Sea, and which are bound to any Swedish Harbour in the same, on this Side of the Sound, have Liberty, without stopping first at the said Place of Quarantain, to proceed on their Voyage to the several Ports to which they are bound, yet must anchor before they enter, and, pursuant to his Majesty's late Regulations,

deliver their Writings and Documents to the Pilots appointed, who are to convey them to proper Officers in the Place, who, after having examined the same, are without Loss of Time, to permit the Ship to enter into the Harbour and there unload. This is however to be understood only of those Ships, which are provided with proper and required Documents. Those not so provided will be sent to the Place of Quarantain, or entirely denied Entrance, and liable to the Punishment incurr'd by the abovesaid Regulations. Under this Article are likewise comprehended all Ships coming from uninfected Places and bound for any of the Swedish Harbours within the Sound; these are to address themselves to the Swedish Commissary Barckman, residing at Helingsborg, to have their Documents by him examined, as by the former Regulations is required.

3. Ships that come from Places not infected, and which carry only the Manufactures and Product in general of their respective Countries, and are not suspected of carrying other Goods and Merchandizes than such as are mentioned in the following Specification, are exempted from taking any further Certificates from his Swedish Majesty's Ministers; but they are to be admitted by Virtue of those given them by the Magistracy of each Place they come from.

However the Cities of Hamburg, Lubeck and Dantzic are from this excepted, who may with all Conveniency be furnished with Certificates of the Swedish Ministers residing there; except Ships from the two last named Cities laden with Corn and Provisions.

4. Concerning the Regulations before made, about the specifying of the Quality, Goodness, Measure and Weight of what is contain'd in each Bale, Cask, &c. to be exported, it is to be understood, that each Exporter shall only be obliged to declare in gross the Quantity and Quality of the Goods.

Specification of Goods and Merchandizes allowed to be imported in the Swedish Harbours by proper Certificates of the Magistracy in the following Places, viz.

Great Britain.

Grain, Provisions, all manner of Metals and the Manufacture thereof, Minerals, Leather, Hides, Skins, Coals, Leaf-Tobacco, Scots Salt, Galmy and Soap.

Holland.

All manner of Provisions, East-India Spices (imported there by their Company,) Leaf-Tobacco, all Sorts of earthen Ware and Galmy.

Portugal.

Salt, Wine, Fruits, dry, preserved or pickled, Oil, (on Condition that the said Goods by the proper Certificates of the Magistrates are attested to be the Growth and Product of the Country,) likewise Leaf-Tobacco from Brasil.

Spain.

Salt, Wine, Fruits, dry, preserved or pickled, Oil, (on the same Condition of Certificates as those of Portugal,) Virginia Leaf-Tobacco, Hides from Cartagena and Havana.

Of the Growth and Product of Brandenburg, Prussia, and Pomerania.

Provisions, Hemp, Flax, and Wooll, (attested by the respective Magistrates to be the Growth and Product of those Countries,) Wax, Pot-Asnes, Tallow, Clapboards, Plaster of Paris, Money, Lead, and Salt-Petre.

Dantzic, Hamburg, and Lubeck.

All Manner of Provisions and Grains.

SPARRE.

Whitehall, April 16, 1722.

This is to signify in His Majesty's Name, that if any Person or Persons shall hereafter apprehend any one or more Highwaymen, who from and after the Date hereof shall have robbed any of the Mails, or shall have been concerned as Accomplices in the robbing of any of them, such Person or Persons shall have a Reward of Two Hundred Pounds for each Offender, who shall be convicted thereof, to be paid by the Receiver General of the Post-Office; over and above the Reward directed by Act of Parliament for apprehending of Highwaymen; or if any Person hereafter concerned in robbing any of the Mails shall make a Discovery of the same, so that his Accomplice or Accomplices shall be convicted thereof, such Person shall have His Majesty's most gracious Pardon, and also receive the Reward of Two Hundred Pounds for each Offender so convicted, to be paid as aforesaid.
