(b) in Pretoria Avenue, on the south-west side, to:

(i) shorten the existing shared use parking place opposite Nos. 38 to 40;

(ii) shorten the existing shared use parking place opposite Nos. 30 to 34;

(iii) provide 3 disabled parking places opposite Nos. 24 to 28;

(iv) provide single yellow line waiting restrictions opposite Nos. 34 to 36; and

(v) reduce the existing single yellow line waiting restrictions opposite Nos. 20 to 24.

PROPOSED WAITING RESTRICTION AMENDMENTS

THE WALTHAM FOREST (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. *) ORDER 2013

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Waltham Forest propose to make the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Order would be:

(a) in **Francis Road** to reduce the existing double yellow line "at any time" waiting restrictions, on the north-east side, at its junctions with Lawton Road, Brunswick Road and Scott's Road;

(b) in **New Road** to extend the existing double yellow line "at any time" waiting restrictions on the north-west side, north-east of its junction with Mapleton Road for a distance of 16 metres;

(c) in **The Charter Road IG8** (both sides) to introduce double yellow line "at any time" waiting restrictions outside the Woodford County High School for Girls;

(d) in **Ashley Road** to extend the existing double yellow line "at any time" waiting restrictions on, the east side, at its junction with Westward Road;

(e) in **Burnside Avenue** to extend the existing double yellow line "at any time" waiting restrictions on, (1) both sides west of its junction with Leonard Road; and (2) the north side east of its junction with Rowan Avenue;

(f) in **Burnside Avenue** to provide new double yellow line "at any time" waiting restrictions on, (1) the south side opposite Nos. 1 to 15; (2) the north side, across the access road in between Nos. 23 to 27 and 31; (3) the south side, outside Chingford Hall Primary School; (4) the south side, opposite No. 51;

(g) in **George Road** to reduce the existing double yellow line "at any time" waiting restrictions, (1) on the south side outside Nos. 1 to 10 Higham House; and (2) on the north side west of its junction with Chingford Mount Road;

(h) in **Hazel Way** to extend the existing double yellow line "at any time" waiting restrictions at its junction with Maple Avenue;

(i) in **Leonard Road** to reduce the existing double yellow line "at any time" waiting restrictions, (1) on both sides at its junction with Chingford Mount Road and (2) the north side, outside No. 69;

(j) in **May Road** to extend the existing double yellow line "at any time" waiting restrictions on, the east side, adjacent to No. 66 Leonard Road;

(k) in **Westward Road** to reduce the existing double yellow line "at any time" waiting restrictions on the south side, at its junction with Chingford Mount Road.

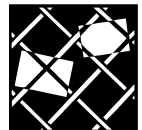
