Any person desiring to question the validity of the orders or of any provision contained therein on the ground that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made there under has not been complied with may, within six weeks from the date on which the orders were made, make application for the purpose to the High Court.

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Greenwich on 13th October 2014 made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The Orders will come into operation on 20th October 2014.

2. The general effect of the Orders will be:

- (a) in Ashburnham Place, on the north side adjacent to No. 18 Langdale Road, to remove the 20-metre permit parking place and replace it with single yellow line 'controlled hours' waiting restrictions;
- (b) in Thaxted Road, on the north-west side outside No. 23 Thaxted Road, to remove the 3.5-metre permit parking place and replace it with single yellow line 'controlled hours' waiting restrictions;
- (c) in John Harrison Way: (1) on the south-east side, adjacent to No. 128 Metcalfe Court, to remove a 10.5-metre loading bay and replace it with a limited waiting place that would operate between 9am and 6.30pm on any day with a maximum stay period of 2 hours (no return for 3 hours); and (2) on the south-east side, approximately 20 metres south-west of Teal Street, to remove 13 metres of limited waiting space and replace it with a loading place that would operate between 9am and 6.30pm on any day with a maximum loading period of 20 minutes (no return for 1 hour);
- (d) to provide double yellow line 'at any time' waiting restrictions in the lengths of street referred to in the Schedule to this Notice;
- (e) to provide 'at any time' waiting and loading restrictions in Eltham High Street: (1) the south side, for 12 metres outside Nos. 150 to 156 Eltham High Street; (2) the south side, for 12 metres across the entrance to the unnamed access road adjacent to No. 94 Eltham High Street; and (3) the unnamed access road adjacent to No. 94 Eltham High Street, throughout its length; and
- (f) to make certain other changes to bring the parent Orders in line with the on-street layout.
