Abstratt of an Att to impower His Majesty to fecure and detain such Persons as His Ma-jesty shall suspets are conspiring against His Person and Government.

WHereas there has been a traiterous and detestable Conspiracy formed and contrived, and is still carrying on by Papists, and other wicked Persons, for invading this

Realm, and to raile Inforrections and Rebellions within this Kingdom, to the utter Ruin and Subversion of the Protestant Re-ligion, and the Laws and Liberties of this Kingdom: For the better Preservation of His Majesty's sacred Person, and for securing the Peace of this Kingdom, in this Time of imminent Danger, against all Attempts and Conspiracies whatsoever; Be it enacted, That every Person or Persone, that are or shall be in Prison within the Kingdom of Great Britain, upon the Tenth Day of October, One thousand seven hundred twenty two, or after, by Warrant of His said Majesty's most Honourable Privy-Council, signed by Six of the said Privy-Council, for High Treason, Suspicion of High Treason, or treasonable Practices, or by Warrant signed by any of His Majesty's Secretaries of State, for such Causes, as aforesaid, may be de-tained in Custody without Bail, until the twenty fourth Day of October, One thou-sand seven hundred and twenty three; and that no Judge or Justice of the Peace shall Bail or Try any such Person, without Order from His said Majesty's Privy-Council, signed by Six of the said Privy-Council, till the said twenty fourth Day of October, One thousand seven hundred twenty three.

That the Act made in Scotland, in the Year of our Lord One thousand seven hundred and one, intituled, Ast for preventing Wrongous Imprisonment, and against undue Delays in Tryals, in so far as the same may be construed to relate to Cases of Treason, and Suspicion of Treason, be suspended until the said twenty sourth Day of October, One thousand seven hundred and twenty three; and that until the said Day no Judge, Justice of Peace, or other Officer of the Law
