

Whitehall, Oct. 24, 1722.

Whereas Hampton Mason, late an Inhabitant of Lynn Regis, and Master of the Ship Hampton and Elizabeth, freighted with a valuable Cargo at Rotterdam, to be carried from thence to Malaga in Spain, did come with the same on the Coasts of Lincolnshire and Norfolk, and there clandestinely sold the Cargo, and afterwards the Ship was burnt near Yarmouth, and there is great Reason to suspect that she was set on Fire on Purpose by the said Master, in order to conceal his having embezzled the said Cargo, and to defraud the Merchants; His Majesty is pleased, for the better Discovery of the said Crimes, to promise His most Gracious Pardon to any Person or Persons concerned therein with the said Hampton Mason, who shall discover him, so as he may be apprehended and convicted thereof, or who shall convict him, after his being apprehended by any other Person or Persons.
