

c. upon completion of the marina, to amend the limits of the statutory harbour of Milford Haven, as defined in the Milford Haven Conservancy Act 1983 to remove the area of the marina from the area of the statutory harbour which is within the jurisdiction of the Milford Haven Port Authority (MHPA);

d. to enable the applicant to arrange with the MHPA for the installation of guidance and holding buoys within the Milford Haven ("the Haven") outside the entrance to the marina;

e. to make provision to ensure that the construction and operation of the marina is undertaken in a manner which does not prejudice the safety of vessels using the statutory harbour of Milford Haven; and

f. to give the MHPA powers to require the applicant to remedy any siltation caused by the construction and use of the marina which might adversely affect upon the ability of the MHPA to ensure the safe and efficient use and operation of the Haven.

The proposed order would not authorise the construction or alteration of a project or confer development consent. Accordingly, Council Directive 85/337/EEC on the assessment of the effects of certain public and private projects on the environment (as amended) and codified by Council Directive 2011/92/EU does not apply to the proposals and no environmental statement has been supplied.
