#### SALMON AND FRESHWATER FISHERIES ACT 1975 LIMITATION OF THE ANGLIAN NETTING LICENCES

Notice is hereby given that it is the intention of Secretary of State for the Environment, Food and Rural Affairs to confirm an Order made by the Environment Agency under section 26 of the above Act as amended by the Marine & Coastal Access Act 2009.

The Net Limitation Order will continue to limit the allocation of licences to those applicants who held a licence during the previous year for fishing for salmon and migratory trout with drift and non drift nets in the specified area.

An electronic or paper copy of the draft Order may be obtained, free of charge, on application to the Environment Agency undersigned.

### HARBOURS ACT 1964 (AS AMENDED)

#### PROPOSED: THE PORT OF LONDON AUTHORITY (CONSTITUTION) HARBOUR REVISION ORDER 2015 NOTICE OF A HARBOUR REVISION ORDER

NOTICE IS HEREBY GIVEN that the Secretary of State for Transport proposes to make a harbour revision order under section 15 (3) of the Harbours Act 1964.

The proposed order would amend the Port of London Authority Act 1968 (c.xxxii) ("the Act").

Paragraph 7 Part 1 of Schedule 2 to the Act prevents a person over the age of 64 from being eligible to be appointed a member of the Port of London Authority. Paragraph 10 requires a member of the Authority to retire once they have reached the age of 70. Both these provisions will be repealed by the proposed order. This will bring the Port of London Authority Act in line with Government equalities legislation which applies to other public authorities.

The proposed order would not authorise the construction or alteration of a project or confer development consent. Accordingly, Council Directive 85/337/EEC on the assessment of the effects of certain public and private projects on the environment (as amended) which is codified by Council Directive 2011/92/EU does not apply to the proposals and no environmental statement has been supplied.

A copy of the draft order may be inspected at the offices of the Department for Transport at Great Minster House, 33 Horseferry Road, London SW1P 4DR at all reasonable hours until the expiry of the forty-two day period referred to below. Error! Hyperlink reference not valid.

Any person desiring to make an objection or representation concerning the application should write to the Maritime Directorate, Department for Transport, 2/33 Great Minster House, 33 Horseferry Road, London, SW1P 4DR or by email to maritime@dft.gsi.gov.uk An objection or representation should:

- i be received before the expiry of a period of 42 days starting with the date at the foot of this notice;
- ii be made in writing quoting reference PLA2015;
- iii state the grounds of the objection or representation;
- iv indicate who is making the objection or representation; and
- v give an address to which correspondence relating to the objection or representation may be sent.

If an objection is duly made and not withdrawn then the Secretary of State may cause an inquiry to be held. Any objections duly made and not withdrawn and any representations duly made will be considered before the Secretary of State decides whether or not to make the order.
