#### WELSH GOVERNMENT TOWN AND COUNTRY PLANNING ACT 1990 THE STOPPING UP OF HIGHWAYS (ELDON GROVE, RHOSTYLLLEN, WREXHAM) ORDER 201—

The Welsh Ministers propose to make an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping up of the length of highway described in Schedule 1 to this Notice and to improve the length of highway described in Schedule 2 to this Notice to enable the development described in Schedule 3 to be carried out. The Stopping Up of Highways (Eldon Grove, Rhostyllen, Wrexham) Order 201- ("the Order"), if made, will cease to have effect if planning permission in respect of the development expires or is revoked.

During 28 days from 16 October 2015, copies of the draft Order and the deposited plan may be inspected free of charge at the Parish Hall, Vicarage Lane, Rhostyllen, Wrexham LL14 4AR during normal opening hours or may be obtained free of charge from the address below quoting reference qA1222925.

Within the period of 28 days, any person may, by notice to Orders Branch, Transport, Welsh Government, Cathays Park, Cardiff CF10 3NQ, object to the making of the Order.

If you wish to object, support or make representations, the Welsh Government may need to consult persons and organisations outside the Welsh Government. As part of the consultation process, the information you have provided and your personal data will be passed to the applicant/developer and, if necessary, to the local highway authority to enable them to respond to you. The Welsh Government will only disclose your personal details where it is necessary to do so to address the issues raised. Where the Order becomes subject to a Public Inquiry ("PI"), all correspondence is copied to the Inspector of the Inquiry and is available in the PI Library when it becomes publicly available.

##### SCHEDULE 1

Description of the length of highway to be stopped up under this Order

An irregularly shaped length of highway known as Eldon Grove that adjoins the A5152 Wrexham Road at Rhostyllen in Wrexham, having a total area of 74.6 square metres.

##### SCHEDULE 2

Description of the length of highway to be improved under this Order

An irregularly shaped length of highway comprising lengths of Henblas Road, Eldon Grove and the A5152 Wrexham Road, having a total area of 2584 square metres.

##### SCHEDULE 3

The Development

Residential development comprising of 223 dwellings and the construction of new vehicular and pedestrian accesses, at Wrexham Road, Rhostyllen, Wrexham, in accordance with the planning permission granted under Part III of the Town and Country Planning Act 1990 by Wrexham County Borough Council on 1 July 2010 under reference number ESC P/2007/0686.
