Court, came thither likewife to Dinner, which was very fplendid; aiter Dinner His Majefty, together with his Royal Highnefs, leaving the Queen to return to Narwich, went thence to the Lord Townflends Houle at Raynham, where He arrived about fearen at night, attended by the faid Lord, who as Lord Lieutenant of the County of Norfolk, accompanied with the Gentry of the Country, had at first received His Majefty in his pallage from Ewfon to Turmouth, at the Confines of the County, and thence attended him in the whole pallage through the County; His Majefty and the Court having lodged there that night, and the next day, after a great and noble Entertainment, parted thence yefterday morning for this place, where His Majefty arrived about noor, extremity fati fied with His. ved here this Evening. Madrid, Sepz. 18. On Sunday last, it is said, an Express was sent hence to Rome, with a Commission to the Marquis d' Aftorgas, Ambassador there on the part of this Crown, to succeed Don Pedro d' Arrigon, as Vice-Roy of Naples, who is suddainly expected here. We hear nothing farther of the Armada which was sitting out at Cadia for the West Indies, the preparations there to that purpose having been discontinued, upon the advice, as is thought, of the Councel for the West Indies, who at present apprehend that charge not altogether so necessary.

Rome, Sept. 12. On Sunday laft the Spanish Ambasfadar going with the usual Solemnity to St. Maries Maggiore, whither he was according to custom accompanied by the Coaches of several Cardinals, Forreign Ministers, and other the principal perfons of this Court, a dispute hippened to arise, between the Coaches of the Cardinals Chiss and Rospiglios the Portugal Ambassada concerning precedency, upon which, some of the Portugal Ambassadors Gentlemen, endeavoring to vindicate the honor of their Master, felt upon and very much wounded some of the Cardinal's servants, not without occasioning a great disturbance upon the place; of which the said Cardinals having had notice, serv

immediately a party of men, which on the fuddain they had as well out of their own Families, as otherwife got together, to befet the faid Ambaffadors Houle, with directions not to lir thence, till thole Gentlemen, who were retired thither, were put into their hands; but the Popes Guards being in the mean time fent by the Cardinal Patron, to preferve so the Ambaffadors Houfe from any direfpect, the others were forced to retire; the whole bufines(which might otherwifehave occafiohed a great diforder in this City) being in the interim happily accommodated by the Interpofition of the Spanish Ambaffaer, dor.

From Palermo we have advice. of the death of the Cardinal Vifconti, in his Archbishoprick in that Kingdom. Signior Nerli is dayly expected here out of Germany, his Holinel's defigning him, as is faid, fome employment near his perfon. The difference at Avignon between the Popes Officers and the Magistrates of that place, hath been lately composed through the endeavors of that Archbishop.

Yesterday and this day the Pope gave Audience in the Ambaliadors and other publick Ministers here, as likewise to the Bishop of Laon, who delivered his Holiness a Letter from his most Christian Maje; fly, as he did afterwards to the Cardinal Pa-, tron, written with his own hand, as is thought, to press his Holiness to a publick declaring the laid Bishop to have been one of the late promotion.

Venice, Sept. 25. Our Letters from Conftantinople of the 20 path, bring us the unwelcome news of the Bailo de Molino's Ambalfador from this State, being extream ill of a burning Feavor, occafioned by a violent fit of the Stone, infomuch that his Phyfitians, confidering likewile his great age, did feem very much to difpair of his recovery.

The fame Letters farther confirme the news we, had of a diffurbance near Mecca's that the Baffa of that place had lately Married his Daughter to a certain King of the Arabians, with whom he had joyned with what Forces he had under his Command there, having at the fame time ftrengthened his Party with other difcontented perfons, and now feemed, to be in a condition to threaten all thofe parts; that the Grand Signior had been much furprifed hereat, thinking this diffurbance to have taken beginning from the encouragements of the Sultanefs and her, Faction at Conftantinople, at leaft not without her knowledge and connivance, and had thereupon commanded all his Forces which were gathering together near Hungary and thofe other parts, to pafsimmediately into Affa, having appointed a general Rendezvoufe at Bruffa, where heintends to be in perfon

Our affairs in Dalmatia are at prefent wholly at a ftand, till the Porr shall have made choice of a new Plenipotentiary, and he arrived there; Procurator Nani continues still there. This Senate hath lately, for the greater encouragement of their Navigation, and Trade of this place, taken off all the Impositions on Oyles.

Melan, Sept. 12. We are told, of new orders asrived from the Court at Madrid, for the disbanding part of the Forces which have been hitherto kept on foot here, to the great diffatisfaction of all the Nobility, who had promised themselves that upon the 10 often repeated orders from the Queen Regent, the laid Reformation would at length have been put in execution, but yet find themselves deceived in their expectations, Our Governor the Duke d'Offuna making still some difficulty in the matter, pretending he cannot yet proceed therein, till he hath received an answer from the Court, to the Letters he lately sent thither on this Subject. From Florence they tell us, that the Duke and Dutchess Dowager of Mantoua were parted from thence, extreamly fatished with the kind and Magnificent Reception they had there.

Dantzicke, Sept. 29. Our Letters from the Ukfaine, tell us, that the two Crown Generals being joyned with the Forces under their respective Com-niands, had marched with their Horse for the relief of *Rial4 Cierkiew* , (having left their Infantrie at *Kaminiec*) !which had been three times flormed by the Enemies, but were as often beaten back with great lofs; that in their march they had met with Doroschsko's Biother, having a confiderable body as well of Tartars as of Coffacks under his Command, whom they foon routed and put to flight; 200 of the Tartars were taken Priloners, and ma-ny more killed, as also several pieces of Canon taken, which they had not leifure to carry off with them; They farther write, that they began to be very much eafed of the fears they had been in this Summer , as if the Turks delign had been to attempt fomething against this Kingdom, it being certant that the Persians were fallen into Arabia and taken Mecca, which would oblige the Grand Signior to draw all his Forces that way.

The Letters arrived this day from Riga tell us , that the affairs of Muscovy are not yet wholly set-led, there being still those who notwithstanding the exemplary punishment of their chief Leaders, want neither courage nor fuccels in the keeping on Ant the differences and jealoufies against the Czars Government, amongif the Inhabitants of Aftraean and those Countries, where this, Rebellion had its first rife, and hath beensever, fince maintained , infomuch, that the revolted Towns which were faid to have fubmi ted themfelves to the Czars clemency, as we are told, hold out still.
