N humble Address of the High Sheriff, Governour, Deputy-Governours, Justices of the Peace, Clergy, Grand Jury, Gentlemen, and Freeholders of the County of Kerry, at the Quarter Sessions held for the said County at Tralee on the 15th of January 1723, having been transmitted by the Lords Justices of Ireland to his Grace the Duke of Graston Lord Lieutenant of that Kingdom, has by him been presented to His Majesty. Which Address His Majesty was pleased to receive very graciously.

Madrid, Feb. 22, N.S. On the 12th Inflant, the King and Queen, with the Prince and Princes of Aflurias, set out from the Palace here and arrived at Buytrago the same Evening; the Infante Don Carlos went thither the Day before. Mademoiselle de Beaujolois (the Infanta) having been delayed in her Journey by the Indisposition of the Countess de Lemos chief Lady of her Bed-Chamber, could not arrive there till the 14th in the Evening. Their Catholick Majeflies received her Royal Highness at her alighting from the Coach, and conducted her to her Apartment, where the supped with the Infante Don Carlos. That Evening the Chevalier d'Orleans was made a Grandee of Spain. The 15th their Catholick Majesties, with the Prince and Princess of Asturias returned hither. The Infante and Infanta proceeded from Buytrago the 16th: Their Catholick Majesties went out that Afternoon two Leagues from hence to meet them, took them into their own Coach and brought them to the Palace in the Evening; on which Occasion great Rejoyings were made throughout this City, that and the two following Nights. The 18th in the Evening their Catholick Majesties, with all the Royal Family, went to the Church of our Lady of Atocha, attended by the Grandees and foreign Ministers; the Countess de Lemos though indisposed, gave her Attendance on that Occasion, but the next Day desired Leave to retire to her own House for the Recovery of her Health. The Galleons from the West-Indies, consisting of 14 Ships under the Convoy of Four Men of War are all safety arrived in the Ports of Spain, some at Cadiz, and the rest at Pontevedra in Galicia. Preparations are carrying on at Cadiz and other Ports of Andalousia, for an Expedition to Ceuta, which is to be put in Execution about two Months hence.

On Tuesday March the 12th, at Chelsea College, will commence a Payment to all Invalid Out-Pensioners that shall be entituled thereto, one Tears pay, viz. from June 24, 1721, to June 1722; and Attendance will be given every Tuesday, Thursday and Saturday, until the whole Payment shall be made by the Under-Treasurer.
