AST Week the Affembly of the Peafants fent a Letter to the Burghers, by a Deputation of several of their Members, wherein they acquainted the Burghers with the Defire they had of enlarging the King's Power, and required their Concurrence. To this the Burghers returned Answer, that the Matter of their Request was of such a Nature, that they judged it proper first to communicate the same to the Nobility, and take their Opinion upon it. Accordingly on the 9th Instant Twelve of the Burghers were deputed to the Chamber of the Nobility with a Copy of the faid Letter. The Marshal, in the Name of the Nobility, thanked the Burghers for their Participation of that Affair, and told them they would confider of it. This Morning the Nobility came to a Resolution upon the Point in the Peasant's Letter to the Burghers, and declared themselves of a contrary Opinion; as have also the Clergy. The Burghers have taken time to give their

In the late King's Time it was a peculiar Privilege allowed to his Majesty's Sons and Grandsons to go into his Bed-Chamber after all the Courtiers had retired at Night, or in the Morning before any came.

His present Majesty has now granted that Privilege to his Royal Highness the Duke of Orleans, the Duke of Boutbon, the Cardinal du Bois first Minister, the Masshal de Villars, and the Bishop of Freins

the Bishop of Frejus.

Hague, Murch 9, N.S. The States of the Province of Holland are to affemble here To-Morrow. In this Session they will take into Consideration the fitting out of a Squadron of Men of War to cruize this Summer in the Mediterranean, and it is supposed will come to a Resolution upon it. The Deputies from the Chambers of the Admiralty who attend. here till this Affair be determined, have declared that they have not in their Treasury half the Money requisite for fitting out that Squadron; so that some new Provision must be made for the necessary Expence. States will likewise bave under Deliberation, Means for paying the Debts of North-Hol-land; and 'tis thought will during this Seffior, dispose of all the vacant military Employa ments within their Repartition. A Deputas tion from the Province of Zealand is expected here by the 16th Instant. The Republick of Venice have at last given to the States General, in the Credentials of their new Minister appointed to reside here, the Title of High and Mighty Lords, which they had hi-therto disputed. A Letter from the Evangelick Body at Ratisbon to the States General, for a Collection in Behalf of the distressed Protestants in the Empire, is referred to the Consideration of the several Provinces.
