The Secretary of State hereby gives notice of the proposal to make an Order under section 247 of the above Act to authorise the stopping up of three areas of highway lying between Clare Street and Grosvenor Street at Brunswick, in the City of Manchester.

If made, the Order would authorise the stopping up only to enable development to be carried out should planning permission be granted by Manchester City Council. The Secretary of State gives notice of the draft Order under Section 253 (1) of the 1990 Act.

ROYAL BOROUGH OF GREENWICH TOWN AND COUNTRY PLANNING ACT 1990 – SECTION 247 STOPPING UP OF PART OF THE HIGHWAY NEAR THE NORTHERN EXTREMITY OF PEARTREE WAY

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Greenwich on 7th December 2015 has Made an Order under section 247 of the Town and Country Planning Act 1990, entitled the Royal Borough of Greenwich (Stopping Up of Highways) (No. 13) (Thames Link Path - Cycle Way at Northern End of Peartree Way) Order 2015.

2. The general effect of the Order is to authorise the stopping up of the area of highway immediately south of that part of the Thames Link Path being a cycle way extending west of the northern extremity of Pear Tree Way, that area having a maximum length of 78.7 metres and maximum width of 1.15 metres at the westernmost end of that length and 1.56 metres at the easternmost end of that length so as to enable the development described in the Schedule to this Notice to take place. The term "stopping-up" means that this area of highway will cease to be public highway.

3. The stopping-up has been authorised in order to enable the development described in the Schedule to this Notice to be carried out in accordance with the planning permission granted to Taylor Wimpey on 5th December 2012, reference 12/0022/O.

If any person wishes to question the validity of the Order or of any of the provisions contained therein on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within six weeks from the date on which the Order was made, apply for that purpose to the High Court.
