(NO. 1) TRAFFIC ORDER 2016

THE CITY OF WESTMINSTER (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. 209) ORDER 2016

1. NOTICE IS HEREBY GIVEN that Westminster City Council on 8th February 2016 made the above Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders will be, in connection with the introduction of Quietway Route 68 (connecting Bloomsbury and South Bank) on the London Cycle Grid Network, to:

(a) replace all existing single yellow line waiting restrictions on Lancaster Place and Waterloo Bridge (within the City of Westminster) with double yellow line "at any time" waiting restrictions; and

(b) introduce a mandatory cycle lane in the southbound carriageway of Lancaster Place and Waterloo Bridge to replace the existing advisory cycle lane at this location. All vehicles, except cycles, will be prohibited from entering, proceeding or waiting in the cycle lane at any time. The cycle lane will adjoin the existing mandatory southbound cycle lane on the length of Waterloo Bridge within the London Borough of Lambeth. The existing bus stop clearways on Lancaster Place will not be affected.
