- (iv) southbound carriageway approximately 1190 metres south of the entry slip road at Lobley Hill Interchange.

- (ii) southbound carriageway from 340 metres north of the exit slip road at Metro Centre Interchange to 220 metres south of the entry slip road at Coal House Interchange, a distance of 7391 metres.
