### ROAD RESTRICTIONS

**TRANSPORT FOR LONDON****ROAD TRAFFIC REGULATION ACT 1984****THE A201 GLA ROAD (FARRINGDON STREET, CITY OF LONDON) (TEMPORARY PROHIBITION OF STOPPING) ORDER 2016**

1. Transport for London hereby gives notice that it intends to make the above named Traffic Order under section 14(1), (5), (7) and 15(2) of the Road Traffic Regulation Act 1984 and is satisfied that these works will last in excess of 18 months for the purpose specified in paragraph 2.

2. The effect of the Order is summarised in paragraph 3.

2. The purpose of the Order is to enable building redevelopment works to take place at No.20 Farringdon Street.

3. The effect of the Order will be to prohibit any vehicle, except those being used in connection with the redevelopment of No.20 Farringdon Street, from stopping at the eastern kerb-line of A201 Farringdon Street between a point 10 metres north of extended common boundary of Nos. 20 and 25 Farringdon Street and its junction with Old Fleet Lane.

The Order will be effective at certain times from 12:01 AM on the 29th April 2016 until the works have been completed. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:

(1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
