THE BROMLEY (WAITING AND LOADING RESTRICTION) ORDER 2003 (AMENDMENT NO. 145) ORDER 2016.

THE BROMLEY (FREE PARKING PLACES) (TIME RESTRICTED) ORDER 1997 (AMENDMENT NO. 52) ORDER 2016. (HOMESDALE ROAD, BROMLEY)

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bromley hereinafter called "the Council" on 24th May 2016 made the above-mentioned Orders under section 6 of the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part I of Schedule 5 to the Local Government Act 1985 and all other powers enabling, which will come into operation on 6th June 2016.

The effect of the Orders would be to introduce time restricted free parking spaces for motorists wishing to visit the nearby shops as specified in the Schedule to this notice.

The Notice of Making of the above Orders in experimental form published in the News Shopper and The London Gazette on 29th April 2015 contained a statement that the Council would be considering in due course whether the provisions of the experimental Orders should be continued in force indefinitely. The Council has carefully considered and has decided that they should be so continued.

A copy of the Orders and the Experimental Orders can be inspected during normal office hours on Mondays to Fridays inclusive in the Bromley Civic Centre, Stockwell Close, Bromley.

Any persons desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.

Between 10.00am and 6.30pm on Mondays to Saturdays inclusive. 2 hours maximum stay. Noreturn within 1 hour:—

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Croydon proposes to make the above Traffic Orders under Section 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended and all other enabling powers.

2. The general effect of the Orders would be:

(a) to install additional shared use (permit/pay and display) bays in the following locations:-

Gloucester Road

Outside Nos. 108 and 110 – two additional bays

Outside Nos. 30, 32 and 34 – one additional bay

Outside Nos. 68 and 70 – two additional bays

Outside No. 80 – one additional bay

Neville Road

Outside Nos. 37 to 43 - three additional bays

Adjacent to the flank wall of No. 7 Gladstone Road - one additional bay

(b) To remove the existing Neighbourhood Care parking bay outside No. 30 Norbury Crescent and replace it with a disabled parking bay.

3. A copy of the proposed Orders and of all related Orders, of the Council's statement of reasons for proposing to make the Orders and of the plans which indicate each length of road to which the Orders relate, can be inspected between 9am and 4pm on Mondays to Fridays inclusive until the last day of a period of six weeks beginning with the date on which the Orders are made or, as the case may be, the Council decides not to make the Orders, at the Enquiry Counter, 'Access Croydon' Facility, Bernard Weatherill House, 8 Mint Walk, Croydon, CR0 1EA.

6. The Orders are intended to introduce additional shared use parking bays for residents and visitors to use in Gloucester Road and Neville Road and to replace a Neighbourhood Care bay in Norbury Crescent with a disabled bay, at the request of the care home for which the bay was installed.

THE CROYDON (FREE PARKING PLACES) (DISABLED PERSONS) (NO.5) TRAFFIC ORDER 2016

1. NOTICE IS HEREBY GIVEN that Croydon Council on 31 May 2016 made the above Traffic Order under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

2. The general effect of the Traffic Order will be to:
