Any person desiring to question the validity of the Order or of any provision contained therein on the ground that it is not within the relevant powers of the Road Traffic Regulation Act, 1984 or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Order may, within six weeks of the date on which the Order was made, make application for the purpose to the High Court.

6. The Order is intended to introduce disabled parking bays in roads where difficulty is being experienced in the parking of disabled persons' vehicles due to heavy demand for parking in those areas. The order would also revoke those disabled parking bays which are no longer required in order to make best use of kerb space.

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Enfield have made the Enfield (Play Street Restrictions) (No.1) Order 2016 under section 29 to the Road Traffic Regulation Act 1984.

2. The effect of the Order would be to prohibit vehicles from entering or proceeding on the sections of Abbotshall Avenue N14, Devonshire Road N13, Devonshire Close N13, Old Park Road N13, Orpington Road N21, Riverside Gardens EN2 and The Mall N14 as specified in Schedule 1 to this notice on the dates and times detailed in Schedule 2 to this notice.

3. The Order provides that the prohibition would not apply to:

(a) any vehicle requiring access to a property in Abbotshall Avenue N14, Devonshire Road N13, Devonshire Close N13, Old Park Road N13, Orpington Road N21, Riverside Gardens EN2 and The Mall N14;

(b) any vehicle being used for police, fire brigade or ambulance purposes, or for the purposes of a statutory undertaker in an emergency; or

(c) anything done with the permission or at the direction of a police constable in uniform, a traffic warden or a civil enforcement officer.
