Hillingdon Council gives notice that it intends to make these Orders, which will:

**1. Establish permit parking places** (operational between 9.00am and 5.00pm Monday to Friday) in which a vehicle may be left during the permitted hours if it displays a valid IC2 permit in Austin's Lane, Sussex Road & Tavistock Road, Ickenham.

**2. Impose waiting restrictions** in Austin's Lane, Sussex Road & Tavistock Road, Ickenham operational between 9.00am and 5.00pm Monday to Friday with sections of 'at any time' waiting restrictions to prevent obstructive parking.

**3. Establish two shared use permit holder or short stay pay & display parking places** near Nos. 1 to 7 Austin's Lane with charges as shown below.

**4. Establish permit parking places** (operational between 9.00am and 5.00pm Monday to Friday) in which a vehicle may be left during the permitted hours if it displays a valid R2 permit in Sharps Lane, Ruislip between the junctions of Hill Lane and Bury Street.

**5. Impose waiting restrictions** in Sharps Lane, Ruislip between the junctions of Hill Lane and Bury Street operational between 9.00am and 5.00pm Monday to Friday with sections of 'at any time' waiting restrictions to prevent obstructive parking.

**6. Make the following amendments to the previously advertised extension to the Ickenham Parking Management Scheme:**

i) Removal of part of a previously proposed Zone IC2 parking place adjacent to No. 33 Burnham Avenue, Ickenham to be replaced with 'Monday to Friday 9am to 5pm' waiting restrictions.

ii) Removal of part of a previously proposed Zone IC2 parking place outside No. 88 Burnham Avenue, Ickenham to be replaced with 'Monday to Friday 9am to 5pm' waiting restrictions.

iii) Removal of part of a previously proposed Zone IC2 parking place on St Giles Avenue, Ickenham adjacent to No. 77 Glebe Avenue to be replaced with 'Monday to Friday 9am to 5pm' waiting restrictions.

iv) Removal of part of a previously proposed Zone IC2 parking place on St Giles Avenue, Ickenham adjacent to No. 11 Austin's Lane to be replaced with 'Monday to Friday 9am to 5pm' waiting restrictions.

**7. Make the following amendments to Parking Management Schemes to facilitate the installation of new or planned vehicle crossing:**

i) The proposed removal of part of formalised footway parking place adjacent to No. 77 Glebe Avenue, Ickenham.

ii) The proposed removal of part of the Zone IC permit holder parking place outside No. 55 Long Lane, Ickenham to be replaced with 'Monday to Friday 9am to 5pm' waiting restrictions.

iii) The proposed removal of part of the Zone H2 permit holder parking place outside No. 498 Bath Road, Heathrow to be replaced with 'Monday to Friday 9am to 5pm' waiting restrictions.

iv) The proposed removal of part of the Zone H1 permit holder parking place outside No. 21 New Road, Harlington to be replaced with 'Monday to Saturday 9am to 5pm' waiting restrictions.

v) The proposed removal of part of the Zone U6 permit holder parking place outside No. 101 Bridge Road, Uxbridge to be replaced with 'Monday to Friday 9am to 5pm' waiting restrictions.

vi) The proposed removal of part of the Zone U5 permit holder parking place outside No. 3 Nursery Way to be replaced with 'Monday to Friday 8am to 5pm' waiting restrictions.

vii) The proposed removal of part of the Zone U5 permit holder parking place outside No. 6 Nursery Way to be replaced with 'Monday to Friday 8am to 5pm' waiting restrictions.

viii) The proposed removal of part of the Zone SR permit holder parking place outside Nos. 18 and 20 Edwards Avenue to be replaced with 'Monday to Friday 9am to 5pm' waiting restrictions.

ix) The proposed removal of the Zone SR permit holder parking place outside No. 31 Cavendish Avenue to be replaced with 'Monday to Friday 9am to 5pm' waiting restrictions.

x) The proposed removal of part of the Zone SR permit holder parking place near to Nos. 487 to 491 Victoria Road to be replaced with 'Monday to Friday 9am to 5pm' waiting restrictions.

xi) The proposed removal of part of the Zone SR permit holder parking place on Queens Walk adjacent to No. 177 Long Drive to be replaced with 'Monday to Friday 9am to 5pm' waiting restrictions.

xii) The proposed removal of part of the Zone E permit holder parking place outside No. 8 Boldmere Road, Eastcote to be replaced with 'Monday to Saturday 9am to 5pm' waiting restrictions.

xiii) The proposed removal of part of the Zone E2 permit holder parking place outside No. 2 Windermere Road, Eastcote to be replaced with 'Monday to Saturday 9am to 5pm' waiting restrictions.

xiv) The proposed removal of part of the Zone E permit holder parking place outside No. 22 Deane Croft Road, Eastcote to be replaced with 'Monday to Saturday 9am to 5pm' waiting restrictions.

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Newham on 13 June 2016 made the above mentioned Orders under Sections 45, 46, 49, 51 and 124 of the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the East Ham Parking Places Order will be to further amend the Newham (East Ham) (Parking Places) (No. 1) Order 2010 so as to:

a) extend two existing shared use (permit holders and paid-for parking) parking places on the south-west side of Hall Road to replace parts of school keep clear restriction being removed;

b) shorten the existing permit parking place on the north-west side of Kempton Road, outside Altmere Infant School, to allow for a new school keep clear restriction;
