(c) In Low Hall Lane E17 (LHL)

(i) the *northern* side – extend a Free Short Stay parking place situated outside Nos. 38 and 40 LHL westwards to the western flank wall of Nos. 30 and 32 LHL (there will be no change to the hours of operation)

(ii) the *southern* side – introduce a Loading Place between 7am and 7pm Mondays to Saturdays inclusive outside the northern flank wall of No. 64 MHR (between the double yellow line "at any time" waiting restrictions situated outside No. 64 at the junction of MHR and those opposite Nos. 30/32 LHL);

(d) In Ringwood Road E17 (RWR) - the northern side

(i) convert a Free Short Stay parking place situated outside the southern flank wall of No. 97 MHR to a Loading Place to operate between 7am and 7pm Mondays to Saturdays inclusive; and

(ii) introduce a new Free Short Stay parking place 5 metres in length (displacing single yellow line waiting restrictions) immediately east of the Loading Place mentioned in d(i) above operating between the hours of 7am and 7pm Mondays to Saturdays inclusive with a maximum stay of 30 minutes and No return in 2 hours;

(e) In **Queens Road E17** (QR) - the *northern* side to convert double yellow line "at any time" waiting restrictions between a point 6.5 metres west of the eastern flank wall of Nos. 131 and 133 MHR eastwards for a distance of 10 metres to a Loading Place operating between the hours of 7am and 7pm Mondays to Saturdays inclusive; (f) In **Downsfield Road** E17 (DFR) - the *northern* side, to

(i) convert a Free Short Stay parking place situated outside the southern flank wall of No. 118 MHR to a 8 metre Loading Place to operate between 7am and 7pm Mondays to Saturdays inclusive; and (ii) introduce a new Free Short Stay parking place 10 metres in length immediately west of the Loading Place mentioned in f(i) above operating between the hours of 7am and 7pm Mondays to Saturdays inclusive with a maximum stay of 30 minutes and No return in 2 hours; and

(iii) introduce double yellow lines "at any time" waiting restrictions for a distance of 7 metres across the entrance to Markhouse passage (between points 1.5 metres east and west of the flank walls of Nos. 2 DFR and 158 MHR);

(g) introduce a maximum speed limit of 20mph in **Markhouse Road E17** between its junctions with St James's Street and Lea Bridge Road; and

(h) make minor amendments to existing orders so as to accurately reflect parking provisions and restrictions already on-street namely in: **Boundary Road** at its junction with MHR (waiting restrictions and parking place); remove a redundant disabled parking place in **Downsfield Road** at its junction with MHR; double yellow lines "at any time" waiting restrictions in strategic places in all arms of **Lennox Road E17**; a parking place on the east side of **Landsdowne Road E17** and the west side of **Belgrave Road E17**. There will be no changes made on the ground.

NB/ *Copenhagen Style blended crossings will be built over waiting restrictions at the junction of all roads adjoining Markhouse Road E17.
