#### NOTICE OF A DECISION ON AN APPLICATION FOR AN ORDER GRANTING DEVELOPMENT CONSENT

The Secretary of State for Business, Energy and Industrial Strategy ("the Secretary of State") gives notice under regulation 23 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2009 that a determination has been made on an application by Snowdonia Pumped Hydro Limited of 1 Finsbury Circus, London EC2M 7SH ("the Application") for development consent under the Planning Act 2008 ("the 2008 Act").

The Application is to construct, operate and maintain a pumped storage generation station with a maximum generating capacity of 99.9MW utilising disused quarries near Llanberis in Gwynedd. The Application also included other development related to the construction, operation and maintenance of the project.

The Secretary of State has determined, following consideration of the report of the Examining Authority which conducted an examination into the Application, that development consent should be granted and has decided, therefore, to make an Order under the 2008 Act.

The statement of reasons for deciding to make an Order granting development consent, which has been prepared by the Secretary of State under section 116(1)(b) of the Act and regulation 23(2)(d) of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2009, has been published on the Planning Inspectorate's web-site:

#### THE RECONSTITUTION OF THE SELBY AREA INTERNAL DRAINAGE BOARD 2017

Notice is hereby given that the Secretary of State for Environment, Food and Rural Affairs in exercise of the powers conferred upon her by section 3(5) and (7) of the Land Drainage Act 1991, has now confirmed The Reconstitution of the Selby Area Internal Drainage Board 2017 made on 6 March 2017 (S. I. 2017 No. 356) confirming the Scheme submitted by the Environment Agency under section 3(1) of the Act.

The scheme makes provision for:

(i) the reconstitution of the Selby Area Internal Drainage Board so that the number of members elected in accordance with the provisions of section 1 of and Schedule 1 to, the Land Drainage Act 1991 is altered from 26 members to 10 members; and the reduction of the electoral divisions from 5 to 1 and ;

ii) matters supplemental thereto or consequential thereon.

By paragraph 7 of Schedule 3 to the Land Drainage Act 1991, it is provided that if any person aggrieved by an order desires to question its validity on the grounds that it is not within the powers of the Act or that any requirement of the Act has not been complied with he may, within 6 weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicants.

#### EXTENSIONS TO UNDERHILL, GROVE & PORTLAND CONSERVATION AREAS, PORTLAND, DORSET

Notice is given regarding section 69 of the Planning (Listed Buildings and Conservation Areas) Act 1990 that Weymouth & Portland Borough Council's Management Committee on 7 March 2017 resolved to designate extensions at:

Underhill Conservation Area to include: Gardens/land at the rear of Ventnor Rd and Old Hill plus the Old Rectory.

Grove Conservation Area to include: Amenity space opposite St Peter's Church, Allotments at the rear of the Clifton Hotel and Part of Incline Rd plus the Engine Shed.

Portland (Easton, Reforme, Straits, Wakeham) Conservation Area to include:

Garden/land behind Glen Caravan Park & Nos 148-154 Wakeham, Railway line either side of Mermaid Bridge, Garden/land behind 54-84 Wakeham, Nos 11-19 & 15 Moorfield Rd and East side of St George's Rd (Nos 1-28).

The designations are effective immediately.

Conservation area designation may affect a property owner's Permitted Development rights, including the demolition of unlisted buildings and the felling or lopping of trees.
