THE CITY OF WESTMINSTER (WAITING AND LOADING RESTRICTION) (NO. 1) EXPERIMENTAL ORDER 2017

1. NOTICE IS HEREBY GIVEN that Westminster City Council on 18th April 2017 made the above Orders under section 9 of the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders will be, on an experimental basis, to introduce a 2hour maximum stay period on Sundays and Bank Holidays between 10.00 a.m. and 4.00 p.m. in the pay-by-phone bays in St. John's Wood High Street. Sunday and Bank Holiday parking in these pay-by-phone bays will continue to remain free of charge.

3. A copy of the Orders, which will come into force on 29th April 2017, and of other documents giving more detailed particulars of the Orders can be inspected between 9.00 a.m. and 5.00 p.m. on Mondays to Fridays until such time as the Orders cease to have effect at WSP | Parsons Brinckerhoff, Palace Gardens Suite, 27th Floor, Portland House, Bressenden Place, London, SW1E 5RS. 4. The Orders shall provide that, subject to the provisions of section 10(2) of the Road Traffic Regulation Act 1984, the Council's Head of Road Management for the time being, or some person authorised in that behalf by him, may, if it appears to him or that person essential:

- (a) in the interest of the expeditious, convenient and safe movement of traffic;
- (b) in the interest of providing suitable and adequate parking facilities on the highway; or
