ROAD RESTRICTIONS

HIGHWAYS ENGLAND ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(B) THE M48 MOTORWAY (SEVERN BRIDGE HIGH WINDS) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2017

NOTICE IS HEREBY GIVEN that the Secretary of State for Transport has made an Order on 9 May 2017, because of the likelihood of danger to the public, on the M48 motorway in South Gloucestershire, the County of Gloucestershire and the County of Monmouthshire.

The effect of the Order will be to authorise the closure of the M48 motorway between Junctions 1 and 2 over the Severn Bridge -

- a) to all vehicles;
- b) to vehicles over 6ft 9ins/2.1 metres high; and motor cycles

These measures would only be implemented during times of strong winds in the interests of road safety and to prevent danger to the public. The latest information on the M48 Severn Bridge crossing can be found on Severn River Crossing's website at www.severnbridge.co.uk. During the closures described above, traffic would be diverted via the M4 Second Severn Crossing. The carriageway closures, slip road closures and diversion routes would be clearly indicated by traffic signs.

The Order will come into force on 13 May 2017 and have a maximum duration of 18 months.

The closures would not apply to emergency service vehicles.
