THE CITY OF WESTMINSTER (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. *) ORDER 201*

1. NOTICE IS HEREBY GIVEN that Westminster City Council proposes to make the above Order under sections 6 and 124 of and Part IV and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Order would be to replace the double yellow line "at any time" waiting and loading restrictions with single yellow line waiting and loading restrictions to apply between 8.00 a.m. and 6.30 p.m. on Mondays to Fridays in the following lengths of Lisson Grove:

(a) the north-east side, between a point 6.5 metres north-west of its junction with Hayes Place up to the end of the zig-zag markings at the junction of Ashmill Street; and

(b) the south-west side, between a point 7 metres north-west of its junction with Shroton Street up to the end of the zig-zag markings at the junction of Ashmill Street.

3. The proposed Order and other documents giving more detailed particulars of the Order are available for inspection until six weeks have elapsed from the date on which either the Order is made or the Council decides not to make the Order between 9 a.m. and 5 p.m. on Mondays to Fridays inclusive at WSP, Palace Gardens Suite, 27th Floor, Portland House, Bressenden Place, London, SW1E 5RS.
