His Majesty to the House of Commons, commanding their Attendance in the House of Peers; the
Commons being come thither accordingly, His
Majesty was pleased to make the following most
speech, to both Houses gracious Speech to both Houses.

My Lords and Gentlemen,

Cannot open this Seffion, without congratulating you upon the Success of your Endeavours last Year, for the Sasety, Interest and Honour of the Kngdom: The Rife of Publick Credit, the flourishing Condition of our Trade and Manufactures, and the general Tranquility of my People, are the happy Consequences of your prudent Resolutions. It is to be hoped, that the sew Examples, which were made of some notorious Offenders, will be sufficient to deter the most Disaffested from enwill be jufficient to deter the most Dijassetted from engaging in the like desperate and wicked Prastices. The Augmentation you thought sit to make to our National Forces, by Sea and Land, has not only secured the general Quiet of the Kingdom, against any sudden Attempts or Insurrections, but has also given me such Weight and Gredit in all Foreign Negotiations, as greatly contribute towards the Preservation of the Peace of Europe. Gentlemen of the House of Commons,

I will order the proper Officers to lay before you the Estimates for the Service of the current Year. I desire such Supplies only, as you shall find absolutely necessary for preserving the Peace of the Kingdom, and for the Security of my People; and those, I hope, may be raised without laying any additional Charge or Burthen on my

Subjetts.

I must in a particular manner recommend to your Care the Publick Debts of the Kingdom, as the most National Concern you can possibly take into your Consideration. I am persuaded it must be a very great Satisfaction to all my faithful Subjects, to see the sinking Fund improved and augmented, and the Debt of the Nation thereby put into a Method of being so much the somer gradually reduced and paid off: It would be a Work truly worthy of a British Parliament, to begin this commendable Undertaking, and to make such a Progress therein, as, with a strict Regard to Publick Faith and Private Property, may pave the Way to this great and desirable End.

My Lords and Gentlemen,

In the present happy Situation of our Affairs, I have nothing more to recommend to you, than that you would make Use of the Opportunity, which your own good Conduct has put into your Hands, in considering of such farther Laws, as may be wanting for the Ease and Incouragement of Trade and Navigation, for the Employment of the Poor, and for the Exciting and Incouraging a Spirit of Industry in the Nation.

I am fully fatisfied, that the Trade and Wealth of my People are the happy Effects of the Liberties they enjoy, and that the Grandeur of the Grown consists in their Prosperity; and I am as fully persuaded, that all, who wish well to their Country, must agree with me, that it is the vainest of all Delusions to imagine that the Religion, Laws, and Liberties of this Kingdom, can ever be secured, but by Supporting the present Osfability. ment, and Maintaining the Succession in the Protestant Line. Let us therefore heartly join in every thing, that may tend to promote our mutual Happiness, and to extinguish the Hopes of those, who long have been, and fill are restless in their Endeavours to subject this Nation to the whole Train of Miseries, that are inseparable from Popery and Arbitrary Power.

St. James's, January 7. This Day his Excellency Hag Abdelcader Peres, Ambassadour from the Emperour of Morocco, was conducted to his first Audience of His Majesty, by Sir Clement Cottrell Master of the Ceremonies.
