TRANSPORT FOR LONDON

ROAD TRAFFIC REGULATION ACT 1984

THE A3036 GLA ROAD (LAMBETH PALACE ROAD) AND A302 GLA ROAD (ST GEORGE'S ROAD, LONDON BOROUGH OF LAMBETH AND SOUTHWARK) (TEMPORARY PROHIBITION OF STOPPING) ORDER 2018

1. Transport for London hereby gives notice that it intends to make the above named Traffic Order under sections 14(1), (5), (7) and 15(2) of the Road Traffic Regulation Act 1984 and is satisfied that these works will last in excess of 18 months for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.

2. The purpose of the Order is enable building construction works to take place on Lambeth Palace Road in the London Borough of Lambeth and an off-site holding area on St George's Road in the London Borough of Southwark.

3. The effect of the Order will be to prohibit any vehicle except authorised vehicles from stopping at the:

- (1) south-eastern kerb-line of Lambeth Palace Road between a point 136 metres southwest of the southern kerb-line of Royal Street to a point 51.7 metres south-westwards;
- (2) north-eastern kerb-line of St George's Road between a point 5 metre northwest of a point opposite the extended common boundary of Nos. 105 and 107 St George's Road to a point 60 metres north-westwards.

For the purposes of the Order authorised vehicles are those vehicles serving construction authorised by Transport for London.

The Order will be effective at certain times from 8:00 AM on the 13th August 2018 until the works have been completed. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:

- (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
- (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.

5. The Order will be revoked upon completion of these works.

PROPOSED EXTENSION OF FORTIS GREEN CONTROLLED PARKING ZONE

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Haringey proposes to make the above mentioned Orders under sections 6, 45, 46, 49, 51 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders would be to:-

(a) extend the boundary of the Fortis Green Controlled Parking Zone (CPZ) into Annington Road, Church Vale, Fortis Green Avenue, Keynes Close, Lauradale Road and Midhurst Avenue. The parking controls would operate between the hours of 11 a.m. and 1 p.m. on Mondays to Fridays inclusive and would prohibit waiting by vehicles other than in the designated parking places provided during those hours; and

(b) designate permit holders only parking places, in the roads listed in Schedule 2 to this Notice where vehicles displaying a valid, business parking permit, residents parking permit or visitors' permit would be permitted to wait without time limit;

(c) designate shared permit holders and 'pay by phone' parking places in the roads listed in Schedule 3 to this Notice where vehicles:-

- (i) displaying a valid business parking permit, residents parking permit or a visitors' permit would be permitted to wait without time limit; or
- (ii) that have had a period purchased for them to be parked using the 'pay by phone' system would be permitted to wait for a maximum period of 1 hour with no return to that parking place within 1 hour of leaving it.
