1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Haringey proposes to make the above mentioned Orders under sections 6, 45, 46 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, and the GLC General Powers Act 1974, to introduce a raised table under Sections 90A and 90C of the Highways Act 1980 and the Highways (Road Humps) Regulations 1999 and introduce new zebra crossings under section 23 of the Road Traffic Regulation Act 1984, as amended.

2. The footway parking along Wightman Road N8 and N4 and Alroy Road N4 is proposed to be moved on to the carriageway and thus free up footway space for pedestrians. This has necessitated a review of the parking provision along the corridor. However, due to the narrow carriageway width, parking can only be accommodated on one side of the carriageway. It is therefore proposed to alternate parking along the corridor using chicanes. There would obviously be a reduction of overall parking provision in Wightman Road as a result of the proposals.

3. It is proposed that raised tables would be introduced in Wightman Road N8 and N4 at the following locations:-

- (a) outside Nos. 286 to 290 Wightman Road;
- (b) outside Nos. 300 to 304 Wightman Road;
- (c) outside No. 180 Wightman Road.

The raised tables would be 9 metres in length, 75 millimetres in height, with gradients of 1:15 to 1:20 on the ramps and would extend across the full width of the carriageway.
