IS Majesty came this Day to the House of Peers, and being in his Royal Robes seated on the Throne, with the usual Solemnity, Sir William Sanderson, Gentleman-Usher of the Black Rod; was sent with a Message from His Majesty to the House of Commons, commanding their Attendance in the House of Peers; the Commons being come thither accordingly, His Majesty was pleased to give the Royal Assent to

An Act for continuing the Duties on Malt, Mum, Cyder and Perry, to raise Money by way of a Lottery for the Service of the Year 1724; and touching lost Bills, Tickets, Certificates or Orders; and for giving further Time for Payment of the Duties on Money given with Apprentices; and for appropriating the Supplies granted in this Session of Parliament.

An Ast for punishing Mutiny and Defertion, and for the better Payment of the Army and their Quarters.

An Alt for explaining and amending an Ait of

the last Session of Parliament, Institled, An Att to oblige all Persons being Papists in that Part of Great Britain called Scotland, and all Persons in Great Britain resusting or negletting to take the Oaths appointed for the Security of His Majesty's Person and Government by several Atts herein mentioned, to Register their Names and real Estates 3 and for enlarging the Time for taking the said Oaths, and making such Registries 3 and for allowing surther Time for the Enrollment of Deeds or Wills made by Papists, which have been omitted to be enrolled pursuant to an Att of the Third Tear of His Majesty's Reign; and also for giving Relief to Protestant Lesses.
