

**DEPARTMENT FOR TRANSPORT
TOWN AND COUNTRY PLANNING ACT 1990**

The Secretary of State gives notice of the proposal to make an Order under section 247 of the above Act to authorise the stopping up of the whole of the unnamed highway as leads off the B530 Amphhill Road and to the south east of Juniper Drive comprising its Lay-by at Houghton Conquest in Central Bedfordshire.
