- (d) introduce no waiting at any time on the east side of Bexley Road in the vicinity of numbers 281 to 283.
- 3. The general effect of the Bexley (Loading Places) (Amendment No. 10) Traffic Order 2019 would be to revise the existing loading place as follows:
- (a) relocate it from outside 269 and 271 Bexley Road to outside 283 to 289 Bexley Road
- (b) change the hours of operation from Monday to Saturday 8am to 6.30pm, 30 minute maximum stay, no return within 1 hour for any vehicle to Monday to Saturday 7am to 10am and 4pm to 7pm1 hour maximum stay no return within 1 hour for any vehicle.
- (c) The loading place will be a shared limited waiting parking place Monday to Saturday between 10am and 4pm (see item 4)
- 4. The general effect of the Bexley (Miscellaneous Parking Places) (Amendment No. 2) Traffic Order 2019 would be to revise the limited waiting parking place as follows:
- (a) relocate it from outside 273 to 279 Bexley Road to outside 275 to 279 Bexley Road
- (b) change the hours of operation from Monday to Saturday 8am to 6.30pm, 30 minute maximum stay, no return within 1 hour for any vehicle to Monday to Saturday 7am to 7pm, 1 hour maximum stay no return within 1 hour.
- (c) At the shared loading place/ limited waiting place in 3(c) introduce limited waiting Monday to Saturday 10am to 4pm 1 hour maximum stay no return within 1 hour.
- NOTE. The above measures are proposed in conjunction with the relocation of the bus stop on the eastern side of Bexley Road south of its current position. It is not however part of this formal TMO consultation.
