**T**Hursday last the 27th Instant was the Prince of Piedmont's Birth-Day, upon which the Court was numerous at his Anrichamber; but his Royal Highness went down very early to the King's Apartment, to avoid the usual Compliments: However he appeared in the Evening at the Queen's Circle, where all the Nobility attended. It is the Talk at Court, that their Sardinian Majesties, and the Prince of Piedmont, will go to pass this Summer in Savoy.

Madrid, April 24, N. S. The 19th Instant King Lewis and his Queen went to Aranjuez; the Marshal de Tessé went thither the Day following, as likewise did Marquess Scotti Envoy of Parma. Some Days ago Don Michael de Aramburu, and Don Francis Izquierdo, Deputies of the Province of Guipuscoa, accompanied by a great Number of that Province, had Audience of their Catholick Majesties and complimented them on their Accession to the Throne; being introduced by the Count de Salvatierra. The Dutchess of Liria was brought to bed of a Son the 21st Instant. King Philip with the Queen his Consort continue in good Health at St. Ildefonso.
