1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Greenwich on 13th May 2019 made the above-mentioned Orders under section 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The Orders will come into operation on 20th May 2019.

2. The general effect of the Orders will be to:

(a) continue indefinitely the provisions mentioned below of the experimental traffic Orders listed in the Schedule to this Notice, which by way of an experiment, in **Shooters Hill Road** (the slip road outside Nos. 2 to 22 Shooters Hill Road), changed:

(i) the permit holders parking place so that the hours of operation are between 9am and 3pm on Mondays to Fridays inclusive; and
