**SHROPSHIRE COUNCIL
PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS)
ACT 1990, ("THE 1990 ACT"), SECTION 69
DESIGNATION OF THE TILLEY CONSERVATION AREA**

NOTICE IS GIVEN under the provisions of the 1990 Act that Shropshire Council, after consulting with local residents and relevant bodies including Historic England, has determined that the area described in the Schedule to this Notice is an area of special architectural or historic interest and that it is desirable to preserve or enhance its character and appearance. It has accordingly been designated the Tilley Conservation Area at the Cabinet of 1st May 2019.

The principal effects of land being included within the Conservation Area are as follows:

1. The Council is required to formulate and publish proposals for the preservation and enhancement of the Conservation Area.
2. Consent must be obtained from the Council for the demolition of any building in the area other than those exempted by a direction of the Secretary of State then in force (including those with a total cubic content, measured externally, no greater than 115 cubic metres) in the area.
3. Six weeks notice must be given to the Council before works are carried out to any tree in the area.
