ROYAL BOROUGH OF KENSINGTON AND CHELSEA NOTICE OF DESIGNATION OF A CONSERVATION AREA UNDER SECTION 70 (8) OF THE PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990 (AS AMENDED)

The Royal Borough of Kensington and Chelsea designated a new conservation area covering the William Sutton and Samuel Lewis Estates in Chelsea. The new Conservation area was designated on 6 June 2019 and is known as the Chelsea Estates Conservation Area.

A conservation designation introduces additional protections and controls. These include:

- Control over the demolition of unlisted buildings.
- The requirement in legislation and national planning policies to preserve and/or enhance the character or appearance of the conservation area
- New development will be assessed against local heritage policies in the Council's Local Plan.
- Fewer types of advertisements, which can be displayed with deemed consent.
- Control over works to trees.
- Fewer Permitted Development Rights (these allow certain changes to be made without the need for planning permission).
