Notice is hereby given that the City Council has made the following Temporary Road Traffic Order(s):

The City of Manchester (BENDIX STREET, PICCADILLY) (Temporary Prohibition of Vehicular Traffic and No Waiting) Order 2019.

The effect of the Order is to prohibit vehicular traffic on Bendix Street as specified in schedule 1 and No Waiting (8.00am to 6.00pm Monday to Friday and 8.00am to 12.30pm Saturday) as specified in schedule 2.

The alternative routes vehicular traffic will be a) Thompson Street, Cross Keys Street, Bendix Street and Vice Versa b) Rochdale Road, Marshall Street, Mason Street

The City Council is satisfied that this prohibition is necessary in order to facilitate demolition and building works.

The order came into operation on the 08 July 2019 and may remain in force for a maximum period of 28 months. If all necessary works are completed within a shorter period, the Order shall cease to have effect at the end of that shorter period.
