tificate figured by the Officer for the faid Inland Duties from whence fuch Coffee, Tea, Cocea-Nuts or Chocolate shall be brought, that, in case of Coffee, Tea or Chocolate, the Inland Duties charged on such Coffee, Tea or Chocolate so intended to be brought thither, have been actually paid, or that the same have been condemned as forfeited, or was Part of the Stock in Hand of some Druggist, Grocer, Chandler, Coffee-housekeeper, or Chocolate-house-keeper, or other Seller of or Dealer in Coffee, Tea, or Chocolate, or making of Chocolate, And in case of bringing in Cocoa-Nuts, That the same have been duly entered with the Officer or Officers of His Majesty's Customs, or that they were condemned as forfeited, or were Part of the Stock in Hand of fome Druggist or orher Person selling or dealing therein, upon or before the faid 24th of June 1724, of which anAccount had been taken on or before the faid 24th of June 1724, expressing the Quantity and Quality thereof, and at what Place the faid Inland Duties were so paid, or what Port or Place the Customs and Duties were fo paid, or the said Coffee, Tea, Cocoa Nuts or Chocolate were condemned, or of whose Stock in Hand the same were Part, on Pain of Forfeiting the Coffee, Tea, Cocoa-Nuts or Chocolate so brought in, without such Notice or Certificate, and treble the Value thereof, together with the Canisters, Bags, Jars, Boxes, Casks and other Vessels or Package whatsoever containing the fame.

That any Officer or Officers for the faid Inland Duties, may in the Day-time enter into all and every the Warehouses, Storehouses, Rooms, Shops, Cellars, Vaults and other Places made use of for keeping or making any Coffee, Tea, Cocoa-Nuts or Chocolate, by any Druggift, Grocer, Chandler, Coffee-house keeper, Chocolate-house keeper, or other Seller of or Dealer therein by Wholesale or Retale, or making Chocolate, and by Weighing, &c. take an Account of the Quantity and Sorts of the faid Commodities in their Custody.

That every such Owner of the said Commodi-

ties respectively, for refusing or hindering any fuch Officer, &c. to enter any fuch Warehouse, &c. or to take such Account, or for not keeping fuch Scales and Weights, or for keeping any false Weight, or for neglecting or refuling to affift any fuch Officer in such Weighing, or for hindering or obstructing such Officer, &c. therein, shall for

every fuch Offence forfeit 100 1.

That either the Commissioners for the said Inland Duties, or Justices of the Peace respectively, within their respective Jurisdictions in relation to the said Duties, upon Oath before them respectively made of Suspicion of fraudulently concealing Coffee, Tea, Chocolate or Cocoa-Nuts, may, by Warrant under their Hands and Seals respec-tively, impower any Officer or Officers for the faid Duties, either by Day or by Night, but if by Night in the Presence of a Constable, or other Officer of the Peace, to enter all suspected Places, &c. and, as forfeited, to seize and carry away all Coffee, Tea, Chocolate and Cocoa-Nuts there concealed, &c.

Every Person for obstructing or hindering any Officer therein, forfeits 100 l.

That no Coffee, Tea, Cocoa-Nuts or Choco-late, is to be fold, uttered or exposed to Sale,

either by Wholefale or Retale, but when in some entered Warehouse, &c. or in some Warehouse approved by the Commissioners of Gustoms, on Pain of forfeiting all such Coffee, Tea, Cocoa-Nuts and Chocolate, and the treble Value, and all the Canisters, Bags, Jars, Tubs, Boxes, Casks and other Vessels or Package containing the same.

That Coffee, Tea, Cocoa-Nuts or Chocolate, exceeding the Quantity of fix Pounds Weight, removed or carried from one to another Part of this Kingdom, by Land or by Water, without a Permit or Certificate from one or more Officers, &c. for the said Inland Duties, shall be forfeited.

The Officer, &c granting fuch Permit, &c. is therein to limit the Time, &c. for fuch Permit, &c. to continue in Force.

Chocolate.

That Entries upon Oath of all Chocolate made after the 24th of June 1724, must be made at the next Office for the said Duties, within the Times hereafter mentioned, (that is to say,) If made within the Weekly Bills of Mortality, then such Entries to be Windows the said of the Windows of the Part of the Kingdom, then to be made every fix Weeks, on the Forfeiture of 50 l. for every Neg-lest of making such Entry.

The Duties for Chocolate so made, to be paid at the Times following, viz. within the faid Weekly Bills to be paid Weekly, in any ether Part of the Kingdom every fix Weeks, on the For-

feiture of 50 l. for every Neglect of so paying.

That all Chocolate made after the said 24th of June 1724, must, at the Place where the Same ought to be entered, be produced in Papers, each containing one Pound and no more; and fuch Papers must be stamped with such Stamp as shall be appointed by the Commissioners for the Inland Duties.

Chocelate Stock in Hand,

That all Chocolate which shall or ought to be entered on or before the 24th of June 1724; t must, within the Times hereafter mentioned, be brought to be stamped, viz. within the Weekly Bills in 14 Days, in any other Part of the Kingdom within fix Weeks next after the faid 24th of June

That every Maker and Seller of Chocolate, forfeits all Chocolate not so stamped, found in his, her or their Custody, &c. after the End of the hid last mentioned six Weeks, and also so so for every, Pound of fuch Chocolate.

After the Expiration of the field fix Weeks, Chocolate found removing without fuch Stamp is

forfeited.

That for either Counterfeiting the faid Stamp, or for Uttering, &c. Chocolate with a Counterfeit Stamp, the Party shall forfeit 500 l. and suffer 12 Months Imprisonment.

Chocolate for private Use in private Families.

That an Officer for the said Duties, on having three Days Notice in Writing, may give to private Persons, &c. Permission to make Chocolate for private Use only, provided, that if in three Days after the sinishing thereof, such Chocolate is
