##### DESIGNATION OF THE OLD YORK ROAD CONSERVATION AREA

Notice is hereby given that the London Borough of Wandsworth (the Council), in pursuance of its powers under section 69 of the Planning (Listed Buildings and Conservation Areas) Act 1990 has determined that the area described in the Schedule below is an area of special architectural or historic interest, the character or appearance of which it is desirable to preserve or enhance. The Council has therefore designated this area as a conservation area which is to be known as the Old York Road Conservation Area.

The effect of designation as a conservation area is as follows:

1. It preserves or enhances the character and appearance of the conservation area as an area of special architectural or historic interest and the Council is under a duty to formulate its proposals for its preservation or enhancement.
2. In carrying out any functions under the Planning Acts in relation to conservation areas (and in particular determining applications for planning permission and listed building consent) the Council is under a duty to pay special attention to the desirability of preserving or enhancing the character or appearance of those areas.
