1. NOTICE IS HEREBY GIVEN that Westminster City Council on 7th October 2019 made the above Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders will be, in connection with public realm improvement works in the vicinity of the North Wharf Gardens Development on the north side of North Wharf Road (between Hermitage Street and Merchant Square) to:

- (a) relocate the electric vehicle recharging bays westward by 39 metres;
- (b) relocate the existing pay-by-phone parking to provide a continuous bank of parking bays (16 bays).

Please note that, since the notice of proposals was published on 4th January 2019, the layout of the parking bays has been revised, including the provision of an additional pay-by-phone bay.

3. ROYAL BOROUGH OF GREENWICH THE GREENWICH (FREE PARKING PLACES, LOADING PLACES AND WAITING, LOADING AND STOPPING RESTRICTIONS) (AMENDMENT NO. *) ORDER 201* THE GREENWICH (CHARGED-FOR PARKING PLACES) (AMENDMENT NO. *) ORDER 201* THE GREENWICH (PRESCRIBED ROUTES) (NO. *) TRAFFIC ORDER 201*

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Greenwich (hereinafter referred to as "the Council") proposes to make the above-mentioned Orders under sections 6, 45 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders would be to:

(a) on days on which events are being held at Magazine London, Greenwich Peninsula:

(i) prohibit vehicles other than taxis (black cabs and private hire vehicles) from entering Drawdock Road at its junction with Ordnance Crescent;

(ii) provide 'at any time' waiting restrictions that would apply to all vehicles except licenced taxis (black cabs) in the layby on the west side of Tunnel Avenue, between 99 and 122 metres south of Ordnance Crescent;

(b) update the map tiles attached to The Greenwich (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) Consolidation Order 2018 and The Greenwich (Charged-For Parking Places) Consolidation Order 2018 so as to reflect the provisions referred to in sub-paragraph (a)(ii) above.

A copy of the proposed Orders and other documents, including maps, giving more detailed particulars of the Orders are available for inspection during normal office hours until the end of six weeks from the date on which the Orders are made or, as the case may be, the Council decides not to make the Orders, at the Directorate of Regeneration, Enterprise and Skills, Strategic Transportation, Royal Borough of Greenwich, The Woolwich Centre, 35 Wellington Street, SE18 6HQ.
