14.1 No person shall fish or use angling equipment of any kind on the waterway except with the authority of a fishing permit issued by the Company and as a registered member of any fishing or angling club authorised in writing by the Company to use the waterway for the purposes of recreational fishing or angling.

### 15. Alcohol

15.1 No person shall consume alcoholic drinks or beverages on the waterway

### 16. Radio Controlled Apparatus

16.1 No person shall operate a radio and/or remote controlled air or water craft on the waterway.

#### 17. Fires

17.1 No person shall light any fire on the waterway.

## 18. Pollution

18.1 No person shall discharge or throw into the waterway any matter that would or might cause the water in the waterway to become contaminated or polluted

### 19. Obstruction of officers

19.1 No person shall intentionally obstruct any person employed or appointed by the Company in the exercise of any powers or functions conferred on them under or in respect of these byelaws

19.2 No persons not duly authorised by the Company shall purport to exercise any powers of the Company in relation to the waterway.

### 20. Enforcement

An Authorised Officer of the Company on production of evidence of their authority may require any person on the waterway who is doing an act which without the consent of the Company is prohibited by these byelaws to produce evidence of such consent and if the person is unable to do so then the Officer may require them to furnish their name and address and it shall be an offence to fail to do so

### 21. Penalty

Any person who contravenes or fails to comply with any of these byelaws shall be guilty of an offence and liable on summary conviction to an unlimited fine scale.
