Turin, July 26, N. S.

E have Advice from Savoy, that his Sardinian Majesty and the Prince of Piedmont are in good Health, and that they are gone to pass a few Days at Baron Bloni's Seat upon the Banks of the Lake of Geneva. The Count de Sales has been secalled from his Employment of Governour of Savoy, and has retired to his Country House at Vineuf five Miles from bence, where he lives in great Privacy; it is reported that his Difmission was occasioned by his having permitted some Merchants to pass the Barriers during

the Plague in France.

Aix, July 27, N. S. On the 24th Instant great Rejoiciogs were made by the Court at Thopon, on Occasion of the Marriage of the Prince of Piedmont with the Princes Polyxena of Rhinfeltz being celebrated by Proxy at Rottembourg on that Day. After a splendid Feaft, where all the Nobility had the Honour to dine with his Sardinian Majesty, the Court went to take the Air at Ripaille, a Carthusian Convent famous for the Retirement of Amedeo VIII. first Dake of Savoy, after be had refigned the Papacy. M. de Blooi, first Equerry to the Prince, was immediately dispatched to meet the Princess on the Road, and make a Compliment to her from his Royal Highness; and the Marquess de Rivarolles, Grand Veneur, is to wait her Arrival at Lauzanne, to perform the like Ceremony in the King's Name. It is said, her Highness brings with her one of her Sifters, to be educated at the Court of Turin. The Republick of Geneva, after a very respectful Deputation to congratulate his Sardinian Majesty and the Prince, fent to his Highnels a handlome Barge, with a Cockiwain and 12 Men in fine Liveries to row him about for his Divertion on the Lake while he stays in that Neighbourhood: General

Hackbrecht, a Swifs Officer in the King of Sardinia's Service, is preparing a fufficient Num-ber of Boats in the Pais de Vaud to tranfport her Highnels and her Retinue crofs the Lake from Lauzanne to Thonon. It is thought the Marriage will be celebrated on the 17th of August, the Bishop of Annecy being ordered to attend on that Day. The whole Court will immediately come to Chambery, where all the Nobility will be admitted to kile his Majesty's Hand and the Prince and Princess's; and after three Days Rejoicings, the Mourning for Madame Royale will be resumed, and the Court will proceed to Turin. Four Days ago the Marchionesses de St. Thomas and de St. Sebastian, with a great Retinue, went through this Place in their Way to Thonon, in order to

be ready for the Princels's Reception.

Paris, Aug. 2, N. S. The King with the Court returned Yesterday to Versailles from Chantilly. Preparations are making for his Majesty's going to Fontainebleau, the End of

this Month or Beginning of the next.
