1) NOTICE IS HEREBY GIVEN that the Council of the London Borough of Islington proposes to make the above mentioned Orders under Sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended, and of all other powers thereunto enabling.

2) The general effect of the Free Parking Places, Solo Motorcycles Revocation Order would be to revoke the motorcycle parking place opposite Nos. 1 and 3 Hertslet Road.

3) The general effect of the Parking Places Order would be to extend the Residents Permit Parking Place on the south west side of Hertslet Road, opposite Nos. 1 and 3 Hertslet Road.

4) The general effect of the Prescribed Routes Order would be to prohibit vehicular traffic entering or proceeding in Hertslet Road between the south eastern kerb line of Seven Sisters Road and the north western kerb line of Tollington Road other than in a south eastern direction.
