

**LONDON BOROUGH OF LAMBETH  
PROPOSED CHANGES TO THE 'AT ANY TIME' WAITING  
RESTRICTIONS  
(DOUBLE YELLOW LINES) AND EXTENSION OF THE EXISTING  
ROAD HUMP AT THE JUNCTION OF BUCKLEIGH ROAD AND  
KEMPSHOTT ROAD**

*[NOTE: This Notice is about proposals to change the extent of the 'at any time' waiting restrictions (double yellow lines) that currently apply at and near the junction of Buckleigh Road and Kempshott Road and to extend the length of the flat-top road hump known as a "speed table" at the junction of those roads. Objections or other comments may be made – see paragraph 7.]*

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth proposes to make the Lambeth (Waiting and Loading Restriction) (Amendment No. -) Order 202- under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

2. The general effect of the Order would be to change the existing ban on waiting by vehicles 'at any time' at and near the junction of Buckleigh Road and Kempshott Road (which is indicated on the ground by double yellow lines) so that the ban would in future apply in the lengths of those roads specified in the Schedule to this Notice.

3. NOTICE IS ALSO HEREBY GIVEN that the Council of the London Borough of Lambeth proposes to extend the length of the existing flat-top road hump (known as a "speed table") situated at the junction of Buckleigh Road with Kempshott Road so that it would extend through the junction of those roads and along Buckleigh Road for a distance of 21 metres and through the junction of those roads and along Kempshott Road for a distance of 28 metres (both measurements include the gradients).

[A flat-top road hump known as a "speed table" is an elevated section of carriageway, having a maximum height of 100 millimetres above the existing carriageway, with a flat top that extends across the full width of the carriageway from kerb to kerb, so that the flat top of the speed table and the adjoining footways form a continuous surface.]

4. The proposal to change the ban on waiting by vehicles at the junction of Buckleigh Road and Kempshott Road is necessary to improve visibility for drivers at the junction and so improve road safety and the proposal to extend the length of the existing flat-top road hump is intended to assist with general accessibility and improve road safety for pedestrians when crossing the road.

(a) the north-east side, between a point 5.7 metres north-west of the south-eastern boundary of No. 50 Kempshott Road and a point 3.2 metres north-west of the north-western building wall of No. 35a Kempshott Road;

(b) the south-west side, between a point 2.7 metres north-west of the south-eastern boundary of No. 52 Kempshott Road and a point 7.8 metres south-east of the north-western boundary of No. 37 Kempshott Road.

(a) the north-west side, between a point 9.3 metres south-west of the north-eastern boundary of No. 52 Kempshott Road and a point 2.2 metres north-east of the common boundary of Nos. 48 and 50 Kempshott Road;

(b) the south-east side, between a point 3 metres south-west of the common boundary of Nos. 37 and 39 Kempshott Road and a point 1.2 metres north-east of the common boundary of Nos. 35 and 35a Kempshott Road.

FORMAL PROVISION AND REMOVAL OF DISABLED PERSONS'  
PARKING PLACES IN VARIOUS ROADS**

*(Note: This notice is about the making of Orders to formally remove certain disabled persons' parking places where they are no longer required, and to provide them where they are needed. The parking places have already been removed and provided on site, but Orders need to be made to formalise the situation and enable enforcement of the parking places where necessary.)*

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth on 29th January 2020 made the Lambeth (Free Parking Places) (Disabled Persons) (No. 1) Order 2020, the Lambeth (Free Parking Places) (Limited Time) (No. 1) Order 2020, the Lambeth (Brixton "B") (Parking Places) (No. 1) Order 2020, the Lambeth (Brixton "E") (Parking Places) (No. 1) Order 2020, the Lambeth (Brixton Hill East) (Parking Places) (No. 1) Order 2020, the Lambeth (Brixton Hill "D") (Parking Places) (No. 1) Order 2020, the Lambeth (Brixton Hill "F") (Parking Places) (No. 1) Order 2020, the Lambeth (Clapham "C") (Parking Places) (No. 1) Order 2020, the Lambeth (Clapham "L") (Parking Places) (No. 1) Order 2020, the Lambeth (Camberwell) (Parking Places) (No. 1) Order 2020, the Lambeth (Herne Hill) (Parking Places) (No. 1) Order 2020, the Lambeth (Kennington) (Parking Places) (No. 1) Order 2020, the Lambeth (Stockwell) (Parking Places) (No. 1) Order 2020, the Lambeth (Thornton) (Parking Places) (No. 1) Order 2020, the Lambeth (Tulse Hill) (Parking Places) (No. 1) Order 2020, the Lambeth (Vassall "V") (Parking Places) (No. 1) Order 2020 and the Lambeth (Waterloo) (Parking Places) (No. 1) Order 2020, under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders, which will come into force on 3rd February 2020, will be to:

- (1) formally remove the disabled persons' parking places from the locations specified in Schedule 1 to this Notice;
- (2) formally provide disabled persons' parking places at the locations specified in Schedule 2 to this Notice. (these parking places would operate at any time and be for the use of vehicles displaying a disabled person's "blue badge" only); and
- (3) formally remove or provide other types of parking space as and where it is required, to accommodate the removal and provision of the above disabled person's parking places.

3. The parking places referred to in paragraph 2(1) above are no longer on the ground and the ones referred to in paragraph 2(2) above have already been provided, on an informal basis. The proposed Orders are therefore required so that they reflect the parking situation that currently applies on the ground and enable enforcement to be carried out where necessary.

4. The Orders, as originally proposed, also included a proposal to formally provide a disabled person's parking place in Russell Grove outside Nos. 8 and 9. A decision on whether to proceed with the formal provision of this parking place has been deferred for the time being.
