ORDER

UPON the application of the Applicants dated 19 March 2020 (“the Application”)

AND UPON dealing with the Application on paper

IT IS ORDERED THAT:

Pursuant to Chapter 6 (Sub-division B) of Part 12 of the Insolvency (England and Wales) Rules 2016 (SI 2016/1024):

- The County Court cases listed in Schedules A and B (attached to this order) be transferred to the High Court of Justice, Business and Property Courts of England & Wales, Insolvency and Companies List for the purpose only of making this order.

- The Replacement Officeholder shall give notice to the Secretary of State and the Registrar of Companies in respect of the matters listed in Schedules A and B (attached to this order) of the terms of this order as soon as reasonably practicable.

9. Nothing in this order shall release the Outgoing Officeholder from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in Schedules A and B (attached to this order).

10. In respect of each appointment the Outgoing Officeholder shall receive his release as office holder by application to the Secretary of State in accordance with the Insolvency Act 1986.
