NOTICE OF A DECISION ON AN APPLICATION FOR AN ORDER
GRANTING DEVLEOPMENT CONSENT

The Secretary of State for Transport ("the Secretary of State") gives notice under regulation 23 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2009, which apply by operation of regulation 37(2)(a)(ii) of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017, that a determination has been made on an application by Suffolk County Council ("the application") for an order granting development consent under the Planning Act 2008.

The application was for the construction, operation and maintenance of a new multispan single carriageway opening bridge, which via associated approach roads and new roundabout junctions connecting into the existing road network, would link the areas north and south of Lake Lothing, Lowestoft. It also includes new moorings within the inner harbour and a new access road linking Waveney Drive to Riverside Road on the south side of Lake Lothing. The Secretary of State has decided, following consideration of the report of the Examining Authority who conducted an examination into the application, that development consent should be granted and therefore has made an Order under s114, 115 and 120 of the Planning Act 2008
