## THE CITY OF WESTMINSTER (WAITING AND LOADING **RESTRICTION) (AMENDMENT NO. 398) ORDER 2020**

- 1. NOTICE IS HEREBY GIVEN that Westminster City Council on 26th May 2020 made the above Orders under section 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984,
- 2. The Orders will continue in force indefinitely the provisions of the following experimental Orders:
- The City of Westminster (Motorcycle Parking Places) (No. 1) Experimental Order 2018;
- The City of Westminster (Parking Places) (B Zone) (No. 1) Experimental Order 2018;
- The City of Westminster (Prescribed Routes) (No. 2) Experimental Traffic Order 2018; and
- The City of Westminster (Waiting and Loading Restrictions) (No. 1) Experimental Order 2018.
- 3. The general effect of the Orders is to remove the closure at the northern end of the western arm of Paddington Green (adjacent to St. Mary's Church) and:
- (a) remove the motorcycle parking from the west side;
- (b) introduce five shared-use parking spaces on the west side (25 metres):
- (c) introduce five shared-use parking spaces on the east side (25 metres); and
- (d) introduce double yellow line "at any time" waiting restrictions in the remaining lengths of the western arm.
- 4. The Orders, which will come into force on 1st June 2020, and other documents giving more detailed particulars of the Orders are available until 7th July 2020 westminstertransportationservices.co.uk/notices. Please note that documents will not be available for inspection in person until further
- 5. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Orders may, within six weeks from the date on which the Orders were made, make application for the purpose to the High Court.
