Notice is hereby given that the Borough Council of Calderdale (the "acquiring authority") has made The Borough Council of Calderdale (Halifax A629) (Highway Improvements) (West Yorkshire Plus Transport Fund, Phase 1B), Supplement Compulsory Purchase Order 2020 under Sections 239, 240, 246, 250 and 260 of the Highways Act 1980. It is about to submit this order to the Secretary of State for Transport for confirmation, and if confirmed, the order will authorise the acquiring authority to purchase compulsorily the land and the new rights described below for the purpose of:

(1) the construction of a highway between Stainland Road (B6112) and Elland Wood Bottom (A629) from a point on Stainland Road parallel to and east of North Dean Business Park in a south easterly direction over the Calder and Hebble Navigation to a point on Elland Wood Bottom adjacent to Elland Wood in Halifax in the Borough of Calderdale in the County of West Yorkshire;

(2) the improvement of highway at Huddersfield Road (the A629), Elland Wood Bottom (A629), Wakefield Road (A6026), Stainland Road (B6112), Bankhouse Lane, Jubilee Road and Exley Bank and the stopping up of highway outside numbers 381 to 387 Huddersfield Road, Halifax in pursuance of The Borough Council of Calderdale (A629, Southern Section, Halifax) (Highway Improvements) (West Yorkshire Plus Transport Fund, Phase 1B) (Side Roads) Order 2019;
